At 4/19/22 bos meeting, steve stated no private funds were needed, interest rates have changed and aht funds and cpc are being requested.

Vote 3-0-0 to use 50K of the waht fund for this affordable housing project pending an affordable housing deed restriction on both the dwellings and the land.

Woodland Cove representatives Sara Kiser and Penn Lindsey informed us that Wingate will be the administrators of the Woodland Cove housing units. Wingate will manage the rental assistance program. We are waiting for mechanics on how the funds will be transferred. The contract with Wingate is being finalized to state they are agents and that the waft funds are not income. We have already approved the 50K for the first 50 units. Vote 3-0-0 to confirm that an additional 6,000 will be added to the 50K that is coming from the 60K CPA grant that was approved spring 2010 town meeting for 6 affordable housing units in woodland cove phase I. Carl will contact David Heard to be placed on cpa agenda so they are aware of how the 56K will be used.

Funds will be sent to Wingate escrow account after occupancy permit issued in September. We received grant requests for both the additional 6K for woodland cove I and 56K for woodland cove II. Wingate representative to waht will be announced shortly and invited to our sept meeting.

Sandy to send carl and trish a copy of the 60k cpa grant and supporting docs.
