Charles Purdy and Kevin Silva presented the variance request.

Mr. MacDonald stated that there needs to be a deed restriction, a surveyor stamp, and a request for the water line. He also showed concern about the driveway.

Mr. Purdy stated that there is no driveway and that it is part of the yard. He said that the neighbor is family and the owners will park on their property and park sideways in the yard. He stated that the house is in probate and there is a town water line but probate needs to be solved before town water or well usage is determined.

Mr. Perry stated that it goes against the state code if the system is moved closer to the well and that the Board of Health purview is to protect drinking water.

Mr. Purdy stated that the well has not been used in 10 years.

Dr. Wiegandt suggested obtaining a letter from the potential owners that states that they intend to hook up to town water.

**MOTION:** Mr. Perry motioned to approve the variance for the leaching field to be less than 10 feet to the water service with a 2-bedroom deed restriction and a O & M contract for the life of the system. Denial of the waiver for the well with a letter from the owners stating that it will not be a drinking well. Dr. Wiegandt seconded.
