## 4:30 p.m. Signing of Minutes- April 17, 2019

# 4:35 p.m. 15 Ames Island Road, Brian Grady- GAF Engineering- Discussion

Mr. Grady requested to move the discussion to June 19, 2019. Discussion was moved to June 19, 2019.

# 4:40 p.m. 69 Agawam Lake Shore Drive, Brian Grady, GAF Engineering-Variance to State Regulations

On behalf of applicant Catherine LaPlante, Mr. Grady requested the following variances pursuant to 310 CMR 15.405, Local Upgrade Approvals.

## 310 CMR 15.211: Minimum Setback Distances:

**Required:** Soil absorption system shall be 20 feet from a cellar wall. **Provided:** Soil absorption system is 17 feet from the cellar wall.

# 310 CMR 15.221: General Construction Requirements for all System Components:

**Required:** The top of all system components shall be no more than 36' below finished grade.

**Provided:** The top of the soil absorption system is 40' below finished grade.

The above requested variances are necessary due to the small lot size location of Agawam Mill Pond and the location of the structures on the lot. The sewage disposal system has been designed in conformance with Maximum Feasible Compliance given the siting constraints of the lot.

After review and discussion, the Board agreed to grant the variances.

On a motion of Catherine Phinney and seconded by Glenn Monterio, the variances were granted. All in favor. 3-0-0

# 4:50 p.m. David Johnson, Sinners and Saints- Tattoo/Piercing Practitioner Application.

Mr. David Johnson appeared before the Board. Upon satisfactory review of Mr. Johnsons application and portfolio, the Board granted permission to practice tattoo and piercing in the establishment known as Sinners and Saints located at 2 West Central Avenue, East Wareham.

On a motion of Mr. Monterio and seconded by Catherine Phinney, the request for a tattoo and piercing license was granted. All in favor. 3-0-0.

# 5:00 p.m. 3 Glenview Circle- S. Keese, Variance to Local Regulations- Upgrade

On behalf of the LeBeau family, Ms. Keese and engineer Mr. Anthony Esposito appeared before the Board with the following requests:

## 1. Setbacks 15.211 (1)

SAS to Foundation: 14' Title 5, 20'. Please note that these very loose, sandy Carver Wareham soils allow most of the effluent to flow downward, not sideward, therefore no septic effluent affects this wall.

#### 2. 15.221:7

Cover over SAS 3' maximum. Note that a variance can allow a cover over the SAS to be greater than required 3' but less than 5' if the SAS is vented and all the components are H20 loaded. Cover over units 2 & 3 are around 4'. The first unit where the Observation Port is located has <3'.

All other criteria meet or exceeds Title 5 and Wareham BOH criteria. Even with these

minor variances, the engineer considers this a vast improvement over the old, existing system.

After review and discussion, the Board agreed to grant the variances. Ms. Keese inquired if the Professional Engineer would have to attend on May 15<sup>th</sup> (another plan which Ms. Keese feels should be approved in house) and requested a policy be written for all to abide by in regards to "what plans require to have an engineer present and what plans are allowed to be granted in house". Mr. Esposito stated he takes his stamp very seriously and wants this statement on record. He will do his best to attend meetings and if needed, is available to be contacted at any time on his cell phone. Mr. Esposito stated Ms. Keese has been in the field for a long time and is qualified to do the job. He stated all other certified plans by engineers Ms. Keese worked with also did the best to their ability.

Chairman Wiegandt replied all plans are different and each review requires some type of professional knowledge. Each plan is treated as an individual case. It is best if the engineer can be present especially when the plan is an I/A system. Mr. Ethier may make the decision on when, and/or when not, the engineer should attend.

On a motion of Glen Monterio and seconded by Catherine Phinney the variances were granted. All in favor. 3-0-0-.
