4:00 p.m. Signing of Minutes

4:05 p.m. 6 Priscilla Avenue, McKinnon & Keese Eng.- Variance to State & Local Regulations- Upgrade

Ms. Sandra Keese of McKinnon & Keese appeared before the Board to request the following variances:

- 1. S.A.S. to Easterly Property Line 8': Title V, 10'. Note the abutter's cesspool is well over 10' from the shared property line. The abutter has been notified of the November 15th meeting.
- 2. S.A.S. to Easterly Property Line; 2', Title 5. The owner/applicant of the proposed system owns & lives at the adjacent property. The existing S.A.S. lies over 10' from the common property line.
- 3. S.A.S. to Southerly Property Line: 6', Title V 10. This property line abuts the layout of Plymouth Avenue.

One green card was collected. A deed restriction stating the home is restricted to one bedroom has been filed with the Plymouth Registry of Deeds and filed with the Board of Health.

4:10 p.m. 23 White Pine Avenue, Gateway Survey Associates, LLC- Variances to State & Local Regulations- Upgrade

Matthew Langelier of Gateway Survey appeared to request the following variances:

- 1. 15.405(l)(e) Reduction of system setbacks from Bordering Vegetated Wetland from 50' to 12' +/-
- 2. 15.405 (i)(e) A sieve analysis was performed in accordance with department guidance when a percolation test could not be performed because of groundwater.
- 3. Adjusting the previously approved variance from the SAS to the property boundary from 6ft to 7.5 ft. (as requested by the Wareham Conservation Commission).

On a motion of Catherine Phinney, R.N. and seconded by Glenn Monterio the variances were granted. All in favor.
