#### 9. TOWN BUSINESS

a. Discussion and votes to recommend warrant articles.

Present before the board: Ken Buckland

Mr. Buckland spoke about article #11 on the Town Meeting Warrant – Front Yard Storage. He stated that the article had to be very specific otherwise a Judge could throw it out. He said that this was before the town at the last Town meeting however it was taken back for additional changes and has been modified. He also stated that all zoning articles need a 2/3 vote to pass at Town meeting. Selectman Bruce stated that this is long overdue.

**MOTION:** Selectman Tropeano moved to recommend this article. Selectman Teitelbaum seconded.

VOTE: 5-0-0 (Unanimous)

Mr. Buckland spoke about article #12 on the Town Meeting Warrant – Temporary Signs. He stated that the added section is more specific such as replacing "displayed on public or private way" with displayed on privately owned property with permission of said owner. Also add "traffic signs" after "light poles" in the next section.

b. Discussion with lead petitioners re: petition articles.

Present before the board: Sandy Slavin

Ms. Slavin was before the board to talk about her petition article #23 Charter Change-Inclusion of Town Meeting Warrants. She would like to see that all CPC articles automatically be placed on the warrant without the approval of the Board of Selectmen. She would like to have the residents be able to decide on the articles. She said that one of the articles submitted for the past 3 years have been denied, she feels the voters should decide how the CPC funds are spent. Ms. Slavin also brought up that the charter isn't updated.

**MOTION:** Selectman Tropeano moved to not recommend article #23. Selectman

Teitelbaum seconded.

c. Request to place a Memorial Bench on Onset Pier.

**MOTION**: Selectman Tropeano moved to approve the bench request from Jayne Allison for a DuMor Grey Slat, Black Frame 6' Recycled Plastic Slate Bench with 4x6 Zinc Plaque installed at the time of manufacturing. Selectman Scarsciotti seconded.

d. Accept donation from the Friends of the Wareham Free Library Inc., in the amount of \$5,000 and from Margit Price in the amount of \$100 for the Wareham Free Library.
