4. **ANNOUNCEMENTS**

Selectman Tropeano explained that Narcan is available at the Church of the Good Shepherd on the 3rd Thursday of the month and explained that they will also teach you how to use it.

Selectman Tropeano spoke about the problems with the Woodland Cove 40B project, he said just the cost alone to educate the children alone would bankrupt our town. Selectman Slavin explained that a letter has been sent and that the Onset Water Department will also fight to stop this project.

Selectman Tropeano said he received a phone call from a resident expressing concern that she has heard that her water bill and sewer bill will be increasing by 50% - He went on to say that the project will cost \$10 million however it will be over 10 years and the increase will be well under 50% and if nothing is done at this time and they happen to have a blowout on that pipe it would be extremely costly to the Town.

Selectman Tropeano spoke about how residents are responsible to clean up any trees that were removed near their property. He said that the Town will cut the trees down that have fallen over the wires; however the cleanup is the responsibility of the homeowner.

Chairman Slavin went to Boston to attend meetings at the State House, he said that we are not expecting any shortfalls this year and also will be receiving money for the unfunded early voting program. The house has added \$12 million to the circuit breaker program and will also be adding \$2.5 million to the Charter Schools.

Chairman Slavin stated that there is a citizen petition with the state to bring the sales tax back down to 5% from 6.5%, he mentioned that it would be a disaster because funding would be reduced by \$1 billion. He also spoke about the workforce program, clean energy bills and MS4 bill.
