Selectman Teitelbaum continues to work with Town Counsel on some of the litigation issues. He also stated that the by law reviews should begin.

Selectman Munise would like to see public workshops focusing on goals related to the Town as well as addressing individual issues or topics. He stated that he would like to see more coordination between various committees and continue working on the webpage and its efficiency.

Selectman Tropeano would like to see the project for the new building for the Police Department accelerated. He would also like issues with the water districts to be addressed. He suggested that each of the Selectmen visit each precinct to listen to concerns or issues from the residents.

Selectman Slavin would like to focus on a community center combined with a senior center as well as finding a use for the Boys & Girls Club. He will continue to work on the commuter rail and will be working on a gated crossing for the railroad tracks behind Merchants Way to make it safer if there are future plans for a boardwalk. Selectman Whiteside will focus on providing programs that were previously provided by the Boys & Girls Club. She also wants to focus on taking care of the current legal issues.

She asked that each member of the Board provide, in writing, their statement of goals that include plans, time frame, and potential costs. These will be discussed and prioritized at a future meeting.
