Selectman Whiteside wanted to give a shout out to the Wareham Garden Club for the weeding that is done every Wednesday and making the gardens in Town look great.

Don't Trash Wareham has gifted specially designed t-shirts to the volunteers who did the beach cleanup in Onset and town beaches. Their hard work is appreciated.

There will be a book sale at the Wareham Free Library lawn on September 17<sup>th</sup> from 9-4. In addition to the book sale, there will be Christmas-themed books and holiday gifts. Outdoor sales will continue in October weather permitting.

The Unleash the PAWsibilities Youth Arts Contest Gallery is on display at the Main Street Post Office through September 26<sup>th</sup>. They have stopped collecting bottles and cans. Any donations of bottles and cans can go to the OBA.

#### 5. CITIZEN'S COMMENTS

Present before the Board: Claire Smith, Town Moderator

Ms. Smith recommended talking about an alternative venue for Town Meeting taking place in October instead of the High School. She is concerned about the school being open for classes which means students and citizens will be at risk. Selectman Teitelbaum stated there may be a possibility the school will close to allow time to sanitize before students return. Mr. Sullivan also explained that the Town has the appropriate equipment to sanitize the limited spaces in a timely manner.

Present before the Board: Don Jepson

Mr. Jepson stated that there should be something better in place pertaining to COVID-19 testing to make it easier for people who want to travel within the 72 hour required time. Selectman Tropeano stated that there is a fifteen minute test that can be done in Orleans, MA. and a fee is waived only if there are symptoms.

Mr. Jepson also wanted to follow up on the HIF (Harbor Information Form) to see if it has been completed. Mr. Sullivan stated he would check on the status.

#### 6. **BOARD'S COMMENTS**

Selectman Slavin updated the Board regarding back up noises at the park and ride near Maple Springs. Joseph Cardoza was before the Board on July 21<sup>st</sup> asking what can be done about the noises because it was causing a disturbance at 5:00 a.m. Selectman Slavin did check on this and was told that the company runs a training program for other companies and that is the only time training can be done. He lodged the complaint on behalf of Mr. Cardoza, but is not sure anything can be done.

#### 7. <u>DOG HEARING-7:15 P.M.</u>

**MOTION:** Selectman Tropeano moved to open the hearing. Selectman Whiteside seconded. Roll Call: Selectman Slavin-yes, Selectman Tropeano-yes, Selectman Whiteside-yes, Selectman Munise-yes, Selectman Teitelbaum-yes.

VOTE: 5-0-0 (Unanimous)

Selectman Teitelbaum read the report into record. (see attachment)

Selectman Teitelbaum swore in all parties stating their testimony.

Present before the Board: Cheryl Gorveatt-Dill, Animal Control Officer, Lindsey Pease, Aubrey France, Thaddeus France, and Racquel Cardoza.

Ms. Gorveatt-Dill stated that she did not witness the incident. A Wareham Police Officer Pacheco was called after the incident and reported what the parties involved told him.

Ms. Pease stated that she was walking her dog with her son and daughter Payton who is six years old when the other dog ran out and attacked her daughter biting her on the arm and leaving a puncture wound. She said the dogs did not fight and there were no witnesses during the attack. The dog owners came out after the fact. Selectman Teitelbaum asked if Ms. Cardoza approached her after the attack. Ms. Pease stated that Ms. Cardoza followed her when she was trying to comfort her daughter and get her home. She asked Ms. Cardoza to leave her alone, but she continued following her. Ms. Pease felt she was being harassed after asking repeatedly to be left alone which prompted Ms. Pease to call the Police. Selectman Whiteside asked for a description of the dog. Ms. Pease stated that her dog is a rescue dog that weighs seventy pounds and may be a lab and mastiff mix. On Ms. France's testimony, she explained that her dog got out of the house because the door was open. Her dog approached Ms. Pease's dog to sniff him and while Ms. Pease was pulling her dog and daughter away, Ms. Pease's dog bit her daughter, not Ms. Cardoza's dog. Ms. France stated she was outside and witnessed the incident. Ms. Cardoza stated she was in the house at the time of the incident and as two of her children were running into the house, her dog ran out of the house. She went outside after the incident took place. Selectman Whiteside asked what kind of restraint is used on the dog. Ms. Cardoza state a slide chain choke collar is used. Ms. Gorveatt-Dill stated that because there are two different stories, no one is 100% sure which dog attacked, but the fact remains that if Ms. Cardoza's dog was not off property, the incident would not have happened. She also said that her concern is to not see this happen again and even though she has never been to the property for any incident, she recommended deeming the dog at risk for being dangerous. The owners of the residence must have a means to contain the dog on property to avoid escaping. The dog also needs to be walked by a controlling person on a four foot leash and if there are no incidents in two years, the dog will no longer be deemed at risk for being dangerous.

If there are no incidents in two years, the dog will no longer be deemed at risk for being dangerous. Selectman Whiteside seconded. Roll Call: Selectman Slavin-yes, Selectman Tropeano-yes, Selectman Munise-yes, Selectman Whiteside-yes, Selectman Teitelbaum-yes.

VOTE: 5-0-0 (Unanimous)

Selectman Teitelbaum read the complaint letter into record. (see attachment)

Selectman Teitelbaum swore in all parties stating their testimony.

Present before the Board: Cheryl Gorveatt-Dill, Animal Control Officer, Carl Schulz, Denise Schulz, Denise Wok, Darren Boucher, owner and trainer at Evolve Dog Training, Joe Paolino, Leslie Mason, and Judy Hazlett.

Ms. Gorveatt-Dill read into record her report. (see attachment)

Ms. Wok stated that she was walking her two beagles and her Yorkshire terrier. As she passed Mr. Schulz's house, his dog Sierra was running along their electric fence and Mr. Schulz was mowing his lawn. When she was away from his house, Sierra came out of nowhere and attacked her beagle, Gracie, biting at her and jumping on her. Ms. Wok took the handle of her leash and started hitting Sierra to get her to stop. Mr. Schulz eventually arrived and put his dog in house. Ms. Wok stated that Mr. Schulz has paid all of the bills for Gracie without question. She also said her dog is now terrified of big dogs and she herself is afraid to walk by the house because she doesn't trust the electric fence Mr. Schulz has. Selectman Tropeano asked if there have been any past problems with the dog. Ms. Gorveatt-Dill stated no, this is the first complaint involving Sierra. Mr. Schulz stated in his testimony that Ms. Wok was walking her three dogs while he was mowing the lawn. He reiterated that Sierra was running in the yard as well. He explained that a few seconds after she walked by, he heard the dogs barking and immediately ran into the parking lot. At that time he saw Ms. Wok and her three dogs and Sierra running to his house. He put the dog in the house and went back to Ms. Wok. He offered blankets and bandages for the dog and immediately offered to pay any bills that would be incurred. He has since taken several steps with Sierra to keep her safe including no longer allowing her loose in the yard, maximizing the electric fencing, hiring a dog trainer, and enclosing an opening in the backyard. He also stated that characterizing this as an attack is not warranted because the medical report described the injuries to Gracie's abdomen as lacerations, not bites. He does not believe Sierra bit Gracie. Selectman Whiteside asked Mr. Schulz what kind of dog Sierra is. Mr. Schulz stated she is a Blue Tick Hound and he has had her for seven years. Selectman Slavin asked if she is trained to hunt. Mr. Schulz responded no.

Mr. Boucher was before the Board and stated that he has been working with Mr. and Mrs. Schulz's dog for a couple of weeks and the dog is making good progress. He is

working on her control and socialization. She is a great dog and he hasn't had any problems with her training.

Joe Paolino read into record a letter he provided (See attachment)
Leslie Mason read into record a letter she provided. (See attachment)
Judy Hazlett read into record a letter she provided. (See attachment)
Ms. Gorveatt-Dill stated that the area Mr. Schulz lives in is a high traffic area of people and dogs. The first time she went there, she asked Mr. Schulz not to let the dog loose in the yard. She sent a letter instructing when the dog was not under their control, she is to be secured in a building, vehicle, or secure locked enclosure. On August 28th, after the letter was received, the dog was running loose in the yard. Ms. Gorveatt-Dill stated she has zero faith in the electric fence and reiterated the importance of not allowing the electric fence as a means of securing the dog because the attack was unprovoked and resulted in an extremely serious injury to another

This letter is in regard to the hearing regarding Sierra, owned by Carl and Denise Schulz.

My name is Leslie Mason and I reside at 43 Pleasant St. My family has owned this property for 55 years. I have been a dog owner for all of those years and currently own an 11-year-old rescue American English Coonhound named Shannon. It is because of Shannon that I had the pleasure of meeting Carl and Denise Schulz and their American English Coonhound Sierra.

My daily routine includes a walk with my dog around Swift's Beach for 2.5 to 3.5 miles. On our walk we walk down Roby St. where the Schulz's reside. In the Spring of 2015, we met Sierra and her family. Sierra and Shannon became friendly and we interacted on a regular basis. As I carry treats to distract Shannon from cats (not an issue for Sierra who lives with cats) we began to share the treats and Sierra would greet us in anticipation of a treat. Sierra always waited her turn and I never saw any food aggression even when family dogs were present and we all shared. She also remained in the yard, respecting the electric fence when we continued our walk.

Often the Schulz's and I would walk our dogs together (see attached picture) and I never witnessed any aggression towards any other dog that we may have encountered. The dogs enjoy this activity as well as each other's company.

American English Coonhounds are a unique breed of dog that are known for being intelligent, loving and enjoy spending time with their humans. I have observed only loving and positive interactions with Sierra, the Schulz's and the Schulz's two-year-old grandson.

In summary I would trust Sierra in the company of my dog and my family.
