- g. Discussion with Sewer Department and Sewer Commissioners regarding article on Town meeting warrant.

Present before the Board: Mark Draineville, Principal at GHD Engineers, Russ Kleekamp, Engineer with GHD Engineers, Guy Campinha, Director of the Sewer Dept., and Sandy Slavin, Clerk of the Sewer Commission.

Mr. Kleekamp discussed the article for Town meeting seeking up to ten million dollars to solve the issues at the Water Pollution Control Facility. He provided an overview of the plans made for the improvements which include inflow and infiltration flows that overwhelm the treatment facility, the need to modify the facility to meet regulations, and, odor concerns. The improvements would include a new lined basin to manage overflow, adding denitrification filters to meet current design standards, and installing a covered lined basin to not completely eliminate the odor concerns but to manage odor control.

MOTION: Selectman Teitelbaum moved to authorize the Town Administrator as custodian for the auction of three properties taking place November 14, 2019. 62 Rose Point Ave., W. Wareham, 332-334 Onset Ave., Onset, and 156 Blackmore Pond Road, W. Wareham. Selectman Bruce seconded.
