i. Discussion and vote on articles for 2020 Special Town Meeting. Present before the Board: Sandy Slavin, Affordable Housing Trust Ms. Slavin stated that the committee is seeking a source of funding for the Affordable Housing Trust. There are requests for assistance for supporting affordable housing and there are no funds. The article would be asking for 25% of the net profit of Town property.

Present before the Board: Missy Dziczek, Wareham Affordable Housing Trust Ms. Dziczek supports this article for the Town Meeting warrant. She stated it is a great source of revenue, other towns have done it, and it is money not being counted on.

Selectman Whiteside stated that 25% of the net proceeds from the sale of property effects the overall financial condition of the Town and would like to see a more specified plan of what the Affordable Housing Trust is requesting. Selectman Slavin stated concerns regarding the 25% and suggested a cap. Selectman Teitelbaum requested more information involving more specifications including a possible cap as well.

MOTION: Selectman Munise moved to approve the Affordable Housing Trust article on the 2020 Special Town Meeting Warrant. Selectman Slavin seconded. Roll Call: Selectman Slavin-no, Selectman Munise-yes, Selectman Tropeano-no, Selectman Whiteside-no, Selectman Teitelbaum-no.

VOTE: 1-4-0 (Selectman Slavin, Selectman Tropeano, Selectman Whiteside and Selectman Teitelbaum opposed)

j. Close 2020 Special Town Meeting Warrant.

Selectman Tropeano stated that Dakota Partners, developers of an affordable housing project on the corner of Redbrook Road have given residents eviction notices as of December 1st. The residents are currently reside at the Starlight Motel which is being torn down for the project. Dakota Partners provided a presentation of the project before the Board of Selectmen which included giving the current residents of the hotel allowance to reside in the new building. Selectman Tropeano requested that the

Town Administrator halt all permits in order to allow the current residents a place to stay. Mr. Sullivan questioned the legality of halting all permits. Turning Point reached out to Mr. Sullivan who confirmed this was not a condition. He referred Turning Point to seek legal counsel. Selectman Munise suggested that the Chairman, along with Town Administrator provide a letter stating concern of what has been heard.

MOTION: Selectman Slavin moved to authorize the Chairman to draft a letter to Dakota Partners concerning the eviction notices given to the residents staying at the Starlight Motel. Selectman Munise seconded. Roll Call: Selectman Slavin-yes, Selectman Munise-yes, Selectman Tropeano-yes, Selectman Whiteside-no, Selectman Teitelbaum-yes.

10. TOWN ADMINISTRATOR'S REPORT

Mr. Sullivan wanted to recognize the Board of Selectman for being responsible for the grants awarded to Turning Point and Damien's Pantry. A sub grant in the amount of \$25,000.00 for Turning Point will help service at risk and homeless clients and a sub grant in the amount of \$21,500.00 for Damien's Place will use the funding for salaries for its warehouse workers, rent, and purchase of food.

Mr. Sullivan also stated that the Salvation Army will not serve as a location for temporary shelter during the winter for the homeless. Work is being done to identify other buildings within the community including at least one town building to see what is available.

Selectman Slavin attended a commuter rail meeting and discussed the possibility of the commuter rail not going beyond Buzzards Bay due to lack of traffic control.

There will be a Planning Board hearing on November 28th at 6:00 p.m. via Zoom regarding the proposed hospitality rezoning.
