

Wareham Cable Advisory Committee (CAC) Minutes

Thursday, August 25, 2022

Hybrid In-person Town Hall Rm 24 and Virtual Meeting via ZOOM

Meeting called to order at 6:15pm

I. Call to Order/Roll Call

- a. Matt Underhill present
- b. Dan Butler present

All members were present. A quorum was established.

II. Public Participation

- a. Representatives of WCTV (Peter Gold and Linda Scharf) were present and attorney Bill Solomon was present remotely. There were no other members of the public present. There were no public comments offered.

Mr. Butler asked if a provision could be included in the draft Verizon license that would give the Town of Wareham right of first refusal if Verizon intended to withdraw from the Wareham market and sell their existing infrastructure in Wareham. Mr. Solomon stated a provision to that effect could be included. Following some discussion, Mr. Rogers moved that Mr. Solomon be asked to draft appropriate language that would give the Town of Wareham right of first refusal if Verizon intended to withdraw from the Wareham market and sell their existing infrastructure in Wareham, seconded by Mr. Butler. Vote:

- d. Mr. Solomon agreed to draft a provision for CAC review at the September 8 meeting.

- e. Mr. Solomon reviewed his most recent figures for Verizon and Comcast subscribers in Wareham (3,274 and 5,165, respectively). Mr. Solomon stated we should expect a Verizon response to our initial, draft proposal by the middle of September.
