Discussion occurred regarding Mosquito Dam Road which is located in the Centre Cemetery. Chairman Rose presented a map of the Road and was concerned that AD Makespace would be traveling this road quite frequently and thus disturbing the graves located within the Cemetery. Commissioner Miller stated there should be no traffic traveling through the Cemetery.
