Call to Order: Joan Kinniburgh, Chair, opened meeting at 6:01pm.

Roll Call:

Minutes, August 11: Discussion on vote for Joseph W. Conway Sr. Playground at Swift's Beach. Committee voted based on information provided by proponents. Subsequently, information from Facebook addressed safety concerns and fears that vandalism would re-occur. There was no inclusion in proposal that provided possible solutions such as lighting and cameras. Committee feels that proponents were not forthcoming and with future requests more due diligence may be required such as contacting the police department. Now that we are informed, a committee member, may decide to vote at Town Meeting, as a taxpayer, against the original proposal. Question arose whether new members could vote on minutes. This seems to vary depending on town committee.

Barbara Smith made a motion to accept minutes, Jean Connaughton seconded. **Vote: 4-0-0**

Project Updates: Kinniburgh distributed a detailed tracking spreadsheet of funded projects from 2010-2019 (see attached). She has contacted all project sponsors who have provided updates on remaining work and suggested end dates. Information will be included in CP-3 form for the State. The tracking form will be sent to sponsors twice a year. Requirements for a Restriction need to be clarified before a project is funded. Kinniburgh will meet with Derek Sullivan to develop a clear contracting process.

Financial Review:

Pending Invoice Update: Anderson Field Track Resurfacing project: a contract with Cape and Islands Track has not yet been approved by Accounting Department, so invoice approved by CPC at August 11 meeting is on hold in Accounting.
