III. PRELIMINARY BUSINESS

A. Approve meeting minutes: May 4, 2016, June 1, 2016, & June 15, 2016

IV. PUBLIC HEARINGS

A. RDA – Samuel P.M. Gray

Present before the Commission: Sam Gray

A site inspection was made at 41 Bourne Point Road. The project involves repairing a pier within land containing shellfish and within a coastal flood zone. It is proposed to replace the decking and stringers of the existing pier at this site which is 70' in length. No pile replacement is proposed so there would be no disturbance to land containing shellfish. All decking material shall be acq pressure treated wood. A small barge would be used to stage off of alongside the pier during the project. The barge would have to operate during appropriate tidal ranges. All old material would be removed from the site. There is no change in footprint of the pier proposed. Mr. Pichette recommended the issuance of a Negative Determination #2 for the project.

B. RDA – Nona Bryant, c/o G.A.F. Engineering, Inc.

Present before the Commission: Bob Rogers, G.A.F. Engineering, Inc.

A site inspection was made at 179 Sandwich Road. The project involves upgrading a septic system within a coastal flood zone. An existing system is to be replaced with a new title v system within coastal flood zone AE el 14. The new system will be constructed behind the existing farm stand and will be outside the buffer zone to the wetland and the riverfront area. The system will be a pump system. There are no significant grade changes proposed. Mr. Pichette recommended the issuance of a Negative Determination #2 for the project.

C. NOI – Nona Bryant, c/o G.A.F. Engineering, Inc. – SE76-2427

Present before the Commission: Bob Rogers, G.A.F. Engineering, Inc.

A site inspection was made at 179 Sandwich Road. The project involves upgrading the septic system of the existing dwelling within the buffer zone to a coastal bank and within a coastal flood zone. Existing system is to be replaced with a new Title V system and part of the work will be 20' from the top of the coastal bank for the installation of the septic tank and to fill in an existing leach pit. One of the leach pits is within the coastal bank. The new leach field will be on the west side of the property outside the buffer zone to the coastal bank and outside the riverfront area but within coastal flood zone ae el 14. Minor grading is proposed around the leach field. Silt fence is proposed between the work and the resource area. A DEP file # has been received. Mr. Pichette recommended the issuance of an Order of Conditions with standard conditions.

A. RDA – Scott & Elaine Robertson, c/o G.A.F. Engineering, Inc.

Present before the Commission: Bob Rogers, G.A.F. Engineering, Inc.

A site inspection was made at 9 Stockton Shortcut. The project involves the removal of a tennis court and landscaping in the buffer zone to Bordering Vegetated Wetland and within a coastal flood zone. An existing tennis court and surrounding chain link fence approximately 25' from the edge of the wetland and within flood zone VE 17 is to be re moved and replaced with loam and seed to match the existing lawn area which surrounds the court area. Concrete will be excavated and removed from the site. Grading will match existing grade. Silt fence will be installed between the court and the resource area. Mr. Pichette recommended the issuance of a Negative #2 Determination for the project.
