#### 6. Discussion re: unused schools that have been returned to Town control

Chairman Teitelbaum asks if the Selectmen should be re quested to turn two empty school properties to the Redevelopment Authority. Clerk Buckland recommends waiting to request the turning of these properties until the Authority has had more success.

### 7. Update re: status of WRA funds

The Town Treasurer has agreed to pull out the Treasurers files for the office to review for the EDIC funds.

8. Discussion re: WRA Bay Pointe property sale and possible vote re: closing and financing

Clerk Buckland states there is EDIC property on Bay Pointe, extending out to Onset Avenue. The Town would like to sell the property to Bay Pointe. Tim Fay of Bay Pointe requires the CEDA property in order to complete his project, but this is forcing him to divide the phasing for construction. Tim Fay is interested in mortgaging a portion of the property and paying for the other half.

Attorney Bowen states this could be done.

The Authority discusses multiple options for selling, leasing, or mortgaging the property.
