Wareham School Committee February 16, 2023

The Acting Chair (Joyce Bacchiocchi) called the meeting to order at 5:30 p.m., and announced there was a quorum of three members.

<u>Attendance:</u> Joyce Bacchiocchi, Apryl Rossi and Brennan McKiernan, Dr. Matthew D'Andrea, Dr. Andrea Schwamb, and Jamie Wiksten, recording secretary.

Absent: Kevin Brogioli, Geoff Swett.

(Acting Chair Bacchiocchi)

Public Participation:

Lynn Peterson, Paraprofessional for 18 years in the district, is assigned as a BOOST paraprofessional. Ms. Peterson explained that the teachers she works with assign her to the lowest level learners, and claimed she works with more students than a Special Education Teacher. She defined herself a co-teacher.

Deanna Semple, WEA President, shared that she feels the former Superintendent and School Committee, supported a budget recklessly. The budget was created so poorly., not keeping paraprofessional negotiations in mind. She read a message that was handed to her asking about the new positions that have been created in the district, and began speaking to the District Administrator salaries. Ms. Bacchiocchi interrupted Ms. Semple, as she was addressing personnel information that should not be discussed in a public meeting.

Marilyn Ramsey, paraprofessional, shared that she could quit her job now, become a custodian, and make \$3 more per hour.

Mary Nielsen, Paraprofessional, compared the lyrics of a Beatles song to the life of a paraprofessional.

Lara Schofield, Paraprofessional at the High School. She shared the difficulties of working with her population. She believes in her profession, and the support she provides her students, as a tool and thread between the student and the teacher.

Business Report:

Ms. Flynn shared the January Financial Report, pointing out the utilities, transportation, tuition, and fuel costs. Any other tuitions are now paid out the circuit breaker account and will be applying for extraordinary relief.

The Acting Chair asked about extraordinary relief. Ms. Flynn responded that between filing for the claim, and changes in the district needs, the relief would be reopened if there is a greater need in the district claim from the previous year, as students register into the district that were not budgeted for.

Budget Transfer:

Student Services Home Instruction is coded as a salary for our employees. We discovered it is not coded correctly, and should be marked as contract service for tutoring for outside providers.

Ms. Rossi made a motion to approve the budget transfer, seconded by Mr. McKiernan

The second transfer is for WES utilities from instructional services. \$145,000 was budgeted, and to date, there has been a transfer of \$135,000, without knowing what the new building expenses would be.

Ms. Rossi asked about the High School and Middle School and why the new efficient building is costing so much. Ms. Flynn responded that everything is so automated, and the smart boards are constantly running and come into play, and the Middle and High School, we will be able to stay within the confines of the budgets for the building.
