A meeting of the Wareham School Committee was held on Thursday, October 20, 2022 at 6:30 p.m. at

the Multiservice Center, 48 Marion Rd.

The Chair called the meeting to order and lead the meeting in the pledge of allegiance. The Chair

announced the meeting was being recorded by WCTV and audio recorded by Jamie Wiksten.

**Good News:** 

Mrs. Bacchiocchi commented on the Wareham Free Library and the wonderful relationship the school

has with the library and wanted to share her thoughts after some discussion and opinions from the

previous meeting were shared.

AP Qualifying Scores received by Wareham High School students were recognized by the School

Committee.

Student Representative Report:

Indiana Troupe reported that Spirit Week has been a big hit, seniors are in the lead for spirit week, and

the pep rally is Friday. The School partnered with Damien's Pantry and are collecting cans. Tonight there

was a D.C. meeting for the Grade 8 class.

Foreign Language Trip:

Mr. Palladino shared that this trip was previously approved prior to the pandemic. Mr. Palladino shared

the itinerary and authentic French trip planned by Elena Myrtankina, French Teacher, in Quebec City No school days will be missed and the price point is affordable. For every six students there is one

chaperone and a bilingual tour guide.

Mrs. Bacchiocchi inquired about insurance. Mr. Palladino explained there are different levels, and will

make sure there will be the same waiver form used for insurance as the Europe trip.

### **Financial Report:**

Ms. Flynn shared the September Monthly report. Mr. Swett asked if the School Committee should be worried about the Administration and Operation lines. Ms. Flynn responded only to the operations line.

Mr. Swett asked about the tuition for other districts. Ms. Flynn responded that the money has been reserved for these tuitions.

### MCAS Report, Dr. Schwamb

The Chair shared the intent of sharing the scores reported tonight, is not to attack scores, or to look for resolutions tonight.

Dr. Schwamb presented the ELA scores, and noted there was significant growth in Middle School. The non-low Income students were presented as a sub group, Math scores were presented, followed by non-low income students math scores.

DART DATA (DARTs are school districts DESE finds Wareham compatible with.

The <u>Next Generation MCAS</u> test was given in 2017 for the first time, and followed the cohorts beginning from the 2017 test.

Dr. Schwamb shared that while the data is concerning, it is not a surprise. The pandemic created challenges, but the new Superintendent is supportive.

Mr. Rossi asked about the chronic absenteeism and asked if Dr. Schwamb believes it has to do with covid protocols?

Dr. D'Andrea responded that the covid protocols schools have to follow are still impacting attendance, and as far as pulling the data, it would be probable but an incredible amount of effort to do that.

SGP (Student Growth Percentile) is how a student is calculated and tabulated for growth. 50 and above is typical growth. It indicates that staff is working hard for our students.

The Chair asked about Grade 10 ELA, and is writing an issue. Dr. Schwamb responded that it is an issue with the entire state.

Mr. Swett asked for Principals to join Dr. Schwamb.

Dr. D'Andrea shared that Dr. Schwamb worked very hard to put the presentation together.

Dr. D'Andrea also added that we want our students proficient in math and literature, and we are in the middle of the pack of "like" districts. We will look at these numbers over the coming months with student improvement, using the data tonight as a guide.

Mr. Swett spoke of the Wareham demographics, and noted that ¾ of students have greater needs.

Mr. Swett asked about the positions we added, and did it make a difference. Mr. Palladino responded that we currently do not run our core classes because we cut them at the High School level.

Ms. Rossi pointed out that perhaps the impact of social-emotional needs has taken precedents.

Mr. Swett pointed out the Alternative Assessment was a great report, and gives great hope for this population. Ms. Rossi pointed out that Alternative assessments went from 8% to 1%. Mrs. Cote acknowledged the hard work of the elementary school with the ALT scores.

Mrs. Cote and Mr. Palladino shared their concerns that when there are cuts, it will be significant and something we have not seen in years.

Mrs. Chandler integrated that "love" was lost and relationships with students and families. Volunteers are back and making huge strides with the hunger for love.

The Chair thanked everyone for telling it like it is, and rolling up their sleeves to fix it. He does not like teaching to a test, but does believe in teaching to standards.
