Ms. Sherry Quirk, attorney, and Planning Board Associate Member, explained that the Town of Wareham has had a hydro-electric license associated with the Tremont Dam since 1981The dam has been inoperative since 1999. FERC pointed this out and asked the Town of Wareham about a plan on how it will return back to commercial operation. Mr. Buckland, Town Planner, responded to FERC with a proposed plan to meet FERC's requirements seeking money through Town Meeting or the WRA to hire engineers to survey the dam and find out what it will take to bring the dam back to electric production in conjunction with a business opportunity for the Town.

Ms. Whiteside explained that it would take \$20,000 to do the safety update and the hydrology update and that a policy decision needs to be made. Ms. Whiteside recommended that the project be put on the agenda next week for a vote. Then the Board would recommend back to the WRA to provide from their funds, if appropriate to do the studies for the two steps that might be taken-for either decertification or continuation.
