Selectman Teitelbaum read the complaint letter into record. (See attached)

Selectman Teitelbaum swore in all participants stating testimonies.

Present Before the Board: Brandan Muller, William Manguso, Miriam Demauro and Joshua Kimball, Natural Resources Officer.

Officer Kimball read into record the incident report. (See attached)

Mr. Muller stated that his dogs are puppies that do not understand orders yet. Mr. Manguso testified that he has seen the dogs loose three to four times since the summer. He also witnessed Ms. Dimauro trying to exit her boat when the two dogs were barking at her. Mr. Muller asked Mr. Manguso if he has ever witnessed the dogs physically harming any children and anyone elderly. Mr. Manguso responded no. Ms. Dimauro stated that she was attempting to exit the boat until she saw the dogs aggressively running toward her growling and showing their teeth. She stated that she remained on the boat for approximately seven minutes. Her concern is the safety in the neighborhood. Mr. Muller asked Ms. Dimauro if she has ever seen children walking the dogs, playing with the dogs, or seen the dogs on golf carts with any children. Her response was no.

Mr. Muller testified that while he understands all concerns, his neighbors have played with the dogs and children have walked the dogs. They are currently being professionally trained, have been vaccinated and licensed, and are also currently chipped. He has gated the property with a 10 X 10 fence and has installed surveillance cameras in order to keep an eye on the dogs. He has also familiarized himself with the Massachusetts Laws.

Officer Kimball recommended deeming the dogs at risk and explained that the enclosure installed is suited for one dog not two and that it must be increased to a two hundred square foot enclosure. He also recommended that the dogs may leave the property securely and humanely muzzled with a chain or tethering device not to exceed four feet in length by a controlling person 18 years or older. The dogs must be microchipped and shall undergo obedience training from a trainer approved by the Animal Control Officer. After two years of compliance, the dogs shall no longer be considered at risk.

- 1. When not under direct control of a controlling person, the dogs shall be contained within a secure enclosure.
- 2. The dogs may only leave the premises by a controlling person and shall be securely and humanely muzzled and restrained with a chain or tethering device to exceed four feet in length having a minimum tensile strength of three hundred (300) pounds.
- 3. Both dogs shall be microchipped.
- 4. Both dogs shall undergo obedience training from a trainer approved by the Animal Control Officer.
- 5. After two years of compliance, the dogs shall no longer be considered at risk. Selectman Whiteside seconded. Roll Call: Selectman Slavin-yes, Selectman Tropeano-yes, Selectman Munise-yes, Selectman Whiteside-yes, Selectman Teitelbaum-yes.

- 2 mixed breed mutt dogs, black in color are continuously getting loose. Various incidents throughout the summer have occurred where numerous neighbors call about the dogs running loose.
- On October 16th, a Wareham DNR Officer responded to the call of loose dogs that had begun barking at a boater, becoming increasingly aggressive and trapped them on the boat by preventing the boater from coming ashore. Subsequently, while trying to corral the dogs, one had bitten the DNR Officer in the left leg.
- 3. Another Offense on 10/27/2020 where the dogs chased a woman while she was out for a walk.

I request a dangerous dog hearing to be scheduled before the Board.

On October 16th 2020 at approximately 11:45, I Officer Joshua Kimball of the Wareham Department of Natural Resources received a call for 2 loose dogs in the area of Pinehurst Beach. The caller stated that the dogs constantly are getting loose. I immediately knew where these dogs belong to (81 Pinehurst Drive) and told the caller, identified as William Manguso DOB 12/02/54, that I would be on my way. As I hung up the phone from MANGUSO, the caller ID stated that we had an incoming call from a 9-1-1 transfer from the Wareham Emergency Communications Center (ECC). I picked up the phone and a woman, later identified as Miriam Dimauro DOB 01/08/1953 stated that she was trying to come off of her boat and was being harrassed and trapped on her boat by 2 loose aggressive dogs. I told DIMAURO that I would be right there. I left the DNR Office at Town Hall and proceeded to the area. Upon arrival to the area where DIMAUROs boat is moored, I spotted the 2 loose dogs urinating in a flower bed. The dogs were on the corner of Blue Jay Terrace and Pinehurst Drive. The dogs can be best described as 45-60lb brown/black mutts. I exited by cruiser and told the dogs to come home. One of the dogs was slobbering and barking at me. I continued towards the dogs and corralled them into the direction of the residence that they belong at. The dogs were following me with no issues. While walking, suddenly one of the dogs became extremely aggressive and lunged at my left hand. I yelled "no" in the direction of the dog. I then radioed to DNR Deputy Director McGuire to "step it up" as the dogs were now becoming increasingly aggressive. The dog then lunged again at my left side and I punched the dog in the snout. This made the dog even more aggressive, and the dog ultimately bit my left thigh. The bite was roximately 5" away from my knee. I took out my canister of pepper spray to deploy at the dog in the event the dog decided to chomp at my leg again but the dog retreated. I radioed Dispatch that I had been bitten by the dog but did not require medical attention. Additional patrol division units then had arrived. At this time, I arrived at the residence (81 Pinehurst Drive) and began knocking on the door. The dogs then started to roam free again. I began to knock on all of the doors of the residence. There was another dog that was tied up in the backyard that was barking. After numerous knocks at the door, someone finally answered. I asked the man if the dogs roaming around were his dogs, and he stated that they were. He further began to explain that his dogs were supposed to have e-collars on. I then told the man that I had been bitten by his dogs, and that he needed to go secure them. The man, later identified as Brandon Muller DOB 12/22/85, continued to ask me questions while his dogs were running loose. I stated to MULLER that we can discuss this after he goes and contains his animals. MULLER attempted to contain one of the menacing dogs, and another began walking up the street towards the Pinehurst Beach Association clubhouse. I went to retreive that dog, it began growling and eventually went into MULLERs backyard. MULLER provided me his identification and I stated to him that he would be receiving a citation for having a loose dog, and unlicensed dog. The dogs have been in the Town greater than 30 days. I also advised MULLER that the dogs need to be fully contained in the yard by means of fence or chain, and this is about the 6th time this year that we have responded for his dogs being loose. MULLER was advised that the dogs were going to be placed in a 10 day quarantine, due to the bite on me. I also advised MULLER that this information will be forwarded to the Board of Selectman to have a Dangerous Dog Hearing and that I would be recommending euthanasia to the Board. MULLER stated to us to "go in the house and take them then" and we advised him that we are going to follow the proper channels and he would be receiving the hearing information in the mail. MULLER stated that he would go to the veterinarian and voluntarily euthanize his dogs. The citation process was explained to MULLER as well.

In spoke with DIMAURO and she stated that she was trying to exit her boat when the dogs were running loose and acting aggressively, which prompted her call to the ECC. DIMAURO and other neighbors all stated that this is a constant issue with the dogs. I advised DIMAURO and the other neighbors that we would be

having a dangerous dog hearing, and would be requesting euthanasia. DIMAURO and the neighbors that were gathered all stated that they would be in attendance to the hearing if they can make it.

At approximately 1:15pm, MULLER called the police department and was requesting how to pay the fine. The call was transferred to my phone, and I advised MULLER that the instructions to pay the citation were listed on the bottom of the citation. MULLER then stated to me that "he is not in the business to kill animals unless he and his family were going to eat it for food". I told MULLER that I am not in the business of killing animals either, but I am in the business of maintaining safety and order that the residents of the Town of Wareham deserve to have. I then explained the dangerous dog hearing process to MULLER once again, and he stated that he would be moving the dogs out of Town and we would not have to worry about them again. I advised MULLER that dog orders are valid throughout the Commonwealth of Massachusetts. MULLER then stated that he wants to put this all behind him, and pay the citation. MULLER then stated to me that he would happily provide me a band-aid for my wounds, and then hung the phone up.

R Officer Joshua Kimball Injury

Left thigh bite mark from dog tooth, did not break skin. Approximately 5" up from the knee on the back side of my thigh. Area is just uncomfortable and red, did not require EMS treatment at the time as there was no blood drawn. I will continue to monitor the area and will update the report and the DNR Director if medical attention is required.

A copy of this report will be sent to the Board of Selectmen for the dangerous dog hearing.

Dear Mr. Muller:

On November 17, 2020, a public hearing was held before the Board of Selectmen Pursuant to M.G.L. Chapter 140 Section 157 concerning complaints involving dogs owned or harbored by you.

After the close of the evidentiary hearing, based on the testimony heard and exhibits presented, the Board determined that your dog is deemed at risk.

The Board voted the following motion:

- 1. When not under direct control of a controlling person, the dogs shall be contained within a building, vehicle, or secure enclosure.
- 2. The dogs may only leave the premises by a controlling person and shall be securely and humanely muzzled and retrained with a chain or tethering device not to exceed four feet in length having a minimum tensile strength of three hundred (300) pounds.
- 3. Both dogs shall be microchipped.
- 4. Both dogs shall undergo obedience training from a trainer approved by the Animal Control Officer.
- 5. After two year of compliance, the dogs shall no longer be considered at risk.

You are hereby ordered to comply with the above conditions within thirty (30) days of receipt of this notice and have the right to file an appeal in the Wareham District Court within ten (10) days of receipt of this notice.
