SEWER BUSINESS

1. Swifts Beach Project Informational Meeting

Vice-Chairman Giberti passed the meeting over to Mr. Warren to explain what is going on in Swifts Beach, allow him to answer questions asked by the public, as well as give additional information on estimated end dates.

Mr. Warren explained phase one (1) is done, and phase two (2) is being started. The workers ran into steel pipe when only asbestos pipe was anticipated to be found. An additional section was also cut (Roughly 13 feet down) where more piping issues were found. This caused the workers to find plastic pipes at the opposite end of Bayview. Mr. Warren also talked about digging down 180 feet with no issues until the machine was stuck for three (3) days due to cutting through an unforeseen steel pipe. Photographs were taken

of the debris and the pipes. A very important factor to the project is adding safe soil underneath the pipes.

Mr. Warren said phase two (2) said a lot was learned during phase one (1) regarding drawings of the pipes. A Homeowner on Beach Road asked about the road grading which Mr. Warren answered. They also discussed storm drains, maintenance of the pipes, paving, and contractors. Mr. Warren spoke lot regarding the paving and grading of the road(s).
