### 5. SEWER SUPERINTENDENT'S REPORT

- 1. Houses not Connected- Mr. Campinha advised the Board that letters went out from the BOH (Board of Health) to the homes not connected. All letters, which range around sixty-seven, will be mailed out in sections. All mailing should be completed by December. Mr. Campinha also let the Board know that since the letters (4) four homes have been connected. Commissioner Slavin asked if they can get a copy of the letter that has been mailed out. Mr. Campinha replied yes.
- **2. Sump Pumps-** Mr. Campinha advised the Board that DEP grant to help with tying the sump pumps into the storm drains was not honored. The grant was from the state to evaluate our system of storm water. We are still going to do it once we get all the necessary paperwork in order. Next round will be in the Spring.
- **3. Dwelling Units:** Mr. Campinha brought forth to the Board EDU rates per dwelling units, and how there has been some controversy about in-law apartments. The state says if it has a kitchen a sitting area it has to be at least 800 square feet no more than 900, then that is considered a dwelling unit, and we the Town of Wareham charge EDU per dwelling unit.

**MOTION:** Commissioner Dunlop motion to back Mr. Campinha 100% on full EDU rates per dwelling units. Commissioner Slavin seconded.

**4. CZM Grant-** Mr. Campinha advisded the Board that the CZM grant was awarded for the basins, in the amount of \$215,000 to help with the flow.
