03/29/2018 - Received the tenants survey

03/30/2018 – Workman's Comp Insurance is coming due and we need to look to alternatives to helps save insurance costs.

04/06/2018 – Meeting with Cyber Sense to go over the beginning of the DHCD Capital Improvement Plan for the FY19 Plan reflecting out 3-5 years. I am going to enclose once again a copy of the work that needs to be done and has been done. On April 6, 2018 added roofs new projects in a training session in Milford. Please see attached the Board report, we will need a vote on acceptance. I also am presenting to the residents and will have a meeting Thursday 04/19/2018 for Redwood and Agawam.

04/02/2018 - We have officially moved into new office. I really like being here!

04/18/2018 – We have scheduled a free bio hazard training for Maintenance team and they are reaching out to other local Housing Authorities to invite any other LHA's Maintenance teams to join in.

04/12/2018 – DDC Construction came by to measure the windows and doors as well as the asbestos removal company. They think they will be here on May 14/May 15 to start the job. 04/12/2018- Please see attached the costs for the permitting for the new job. \$8.983.20

Deferred Maintenance — We have the following items on our DMP — New rugs and window coverings for Redwood, finish painting all hallways for Redwood, upgrade all co2 and smoke alarms with the 10 year model, remove all broken fencing around trash containers and bring to dump, Design and construct drainage for building #5 and #2 in Agawam, Replace Bollards around building #2, Build a closet around filing cabinets, Building #1 in Agawam repair steps and handrails due to end of useful life of railings and walkway, Upgrade flooring in C14 and A14, D21 one leg of wire from tstat to baseboard is not working will fix in spring when heat goes off, minor leak in b building basement hot water supply to first floor baseboard heater will fix when heat goes off for season
