4. Reports: Friends and Foundation

- a. Friends: N. Rice reported the next book sale will be May 18, 19 and 20. Help with set up and breakdown would be appreciated. The annual Duck Race will be Sunday, May 21. There will be another Library Night at El Mariachi Monday, May 22.
- b. Foundation: N. Rice reported The Bridging the Gap campaign has started. The Foundation comedy night raised \$5,400.

5. Director's Report

- a. Reference Librarian Mel Dyer gave an overview of the work she has been doing. She said there's a lot of one-on-one classes. She's held two Canva graphics classes. She's been spending time in the Stone Room with research requests and the Historical Society.
- b. P. Marshall reported on conversations he had with John Foster, Finance Director, re: a separate account with Settlement Fund money that was created for the Trustees to manage. That account still has about \$8,000 in it. Because of turnover in staff and Trustees over the years, information about this account was inadvertently not passed on, and thus it was only in this conversation that P. Marshall became aware of the account, and then shared the info in this meeting with the Trustees. J. Foster is suggesting, for ease of accounting and to avoid any miscommunication in the future, that the remaining amount be spent. See Update on Settlement Agreement in Section 6.b.i.1.a. below.
