tanks. Selectman Tropeano has some concerns about the increasing of the capacity
and did speak with the Health Agent, Building Commissioner as well as the

Tropeano stated that he also spoke with the Superintendent at the Water Department who would like to hear from the DEP on this. Selectman Slavin would like to hear from the Onset Water Department on this. The board was still waiting for a couple of return receipts and asked that this be put off for another two weeks to allow time for receipt of them. Mrs. Slavin came before the board to ask the applicant if they had any plans to replace the tanks if they don't get approved for the expansion. Mr. Ferreira did say yes, at some point.

#### 8. TOWN BUSINESS

a. Update from Buzzards Bay Coalition re: Onset Projects.

Present before the board: Mark Rasmussen

Mr. Rasmussen stated that they have been awarded a \$350,000 grant from Seaport Council for the Onset Bath House. Mr. Rasmussen spoke about the private fundraising campaign. He said that they have raised \$3.3 million which \$3.2 million was from private gifts and \$1.2 million are from government grants. They have received approvals from the Conservation Commission, DEP and the Army Corps of Engineers to work on Wicket's Island which would include removing remnants of the mansion, removing the poison ivy as well as rebuilding the stairs and adding a pier. The Youth sailing program will be increased this year to 6 weeks and they are adding swimming and kayaking as well. He said the goal is to be able to break ground on the bath house just after the summer season to be ready for next summer.

b. Request from Wareham Historical Society to place signs on town property. They were looking for approval to place signs to advertise for the Antique Faire, Craft Faire & Car show. (Note: Selectman Slavin recused himself)

**MOTION:** Selectman Tropeano moved to approve the request to place signs on Town property. Selectman Scarsciotti seconded.

**VOTE: 3-0-1** (Selectman Slavin abstained)

c. Application from Planet Aid for two (2) collection bins. Selectman Tropeano asked that administrative notice of the file be taken. Chairman Teitelbaum stated that letters were in the file to deny previous applications, a letter from the Board of Health Agent stating that they have ongoing issues with trash around the bins at other locations. Also, in the file were various photos of the collection bins. The board had a discussion on the on the request for the bins and decided not to allow the replacement

d. Continued discussion and possible vote to include articles on special town meeting. Warrant.

Selectman Tropeano would like to see a by-law in place to require that the carriages have locking wheels on the property. This by-law would help eliminate carriages being dumped in the woods and around town. Attorney Bowen stated that he has reviewed a number of shopping cart by-laws. Mr. Sullivan asked that a placeholder be on the Special for Capital items.
