# 9. TOWN ADMINISTRATOR'S REPORT

Mr. Sullivan spoke about the two grants the town has received, the first was for \$72,499 from the Regional Efficiency Grant to help pay for Human Resources function such as updating software, re-writing job descriptions as well as training. The other grant is for \$20,000 from the District Local Technical Assistance from M.G. L. c.43D for expediting permitting program.

# 10. <u>LIAISON REPORTS/INITIATIVE REPORTS</u>

Selectman Slavin said that the Tip program confirmed that the Rte 6 & 28 project which is expected to cost \$18 million is scheduled for 2018/2019. The Bike Path Project is expected to cost \$4 million with a scheduled date of 2022.
