### **10. TOWN ADMINISTRATOR'S REPORT**

Mr. Sullivan and Mr. Menard met today with the Cranberry Growers Association and the Cranberry Growers at Tremont Pond – the pond has been raised a foot and a half and they are all looking for a long term solution.

Mr. Sullivan stated that they did receive one response for the property at 505 Main Street (Old Town Hall) in the amount of \$125,000. He stated that unless the board objects than he would like to enter into negotiations. The board had no objections.

Mr. Sullivan received a letter of resignation from Michael Carlozzi the current Library Director, he stated that he appreciates all his hard work and said that we were lucky to have him.

Mr. Sullivan asked the board to accept the donation in the amount of \$30,000 from Pharmacannis Massachusetts, Inc., he stated that this donation was a good faith gesture to the Town

**MOTION:** Selectman Teitelbaum moved to accept the donation from Pharmacannis Massachusetts, Inc., in the amount of \$30,000. Selectman Bruce seconded.

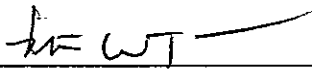
