The Railroad has been contacted to let them know that the brush along Merchant's Way needs to be trimmed.

Selectman Whiteside attended the Historic District Commission meeting in which they discussion the WCTV expansion project, they had a lengthy debate and they had a clear presentation. This discussion was tabled until sometime in August.
