a. Application for a license transfer of an existing year round retail package goods store all alcoholic beverages license and a pledge of license from Jinjas Co., Ltd., The Jug Shop, Adelaide R. DePonte, Manager, 219 Main Street, Wareham to DJP Liquor Corp, d/b/a Jug Shop, Jana R. Banta,

Manager, 219 Main Street, Wareham, under the provisions of Chapter 138 of the Massachusetts General Laws.

Present before the board: Mr. Patel, Ms. Banta, Adelaide DePonte and Attorneys for

both parties.

Mr. Patel was looking for approval from the board to transfer an existing liquor license; he currently manages Wareham Liquors and is tips certified as well as his manager Ms. Banta. Chairman Slavin said that he would also like to ask that he make sure he cleans up the nips around the establishment. Attorney Bowen asked if the owner would relinquish the sale of nips as a license condition. Mr. Patel's attorney stated that they wouldn't be interested in this condition and he has been asked that question in other towns as well, most recently Chelsea.

## 9. TOWN BUSINESS

a. Dog hearing at 7:30 p.m.

**MOTION**: Selectman Tropeano moved to open the public hearing. Selectman Scarsciotti seconded. Poll vote: Selectman Scarsciotti-yes, Selectman Bruce-yes, Selectman Tropeano-yes, Selectman Slavin-yes, Selectman Teitelbaum-yes.

Present before the board: Michelle Ferguson & Cheryl Gorveatt-Dill Ms. Gorveatt-Dill stated that the dogs are not licensed and the owners have been cited for having non-licensed, non-vaccinated and loose dogs and neither citation has been paid. Ms. Gorveatt-Dill stated that on October 10, 2018, the two dogs, described as a tan female Pitbull and black and white male Pitbull, belonging to Rone Ferguson, were running loose in the area of 14 Depot Street and attacked the chickens belonging to Melissa Churbuck, resulting in injury to the birds. The same dogs have displayed aggression towards responding DNR Officers when attempting to capture the dogs. Ms. Ferguson said that she was not at home the day the dogs supposedly

injured the neighbors' chickens and that someone put the dogs in her home. Ms. Gorveatt-Dill stated that the Officers Kimball and Buckminster found the 2 dogs loos and secured them in the house and put a heavy object in front of the door to make sure that they couldn't get out. Ms. Ferguson stated that she did register her dog but wasn't sure if her husband registered his, Ms. Gorveatt-Dill explained that she did go to the Town Clerk's Office and they had no record of either dog ever being registered.

Selectman Tropeano moved to deem the dogs as dangerous and that MOTION: the dogs be confined outdoors in a securely enclosed and locked pen, when the dogs are removed from the premises by the owner, the dogs shall be securely and humanely muzzled and restrained with a chain or tethering device not to exceed 3 feet in length. That the dog only be walked by an adult of 18 years or older, that the owner provides proof of insurance coverage for the dogs, that the owner provides animal control with information by which the dog may be identified throughout its lifetime and that all the fees are to be paid within 7 business days or the dogs will be held in custody until the fees are paid. Selectman Bruce seconded. Selectman Slavin asked Ms. Ferguson if she was going to be able to comply in which she responded that she can try but if not, you can have the dogs.
