Both were before the board giving reasons they believe that the Onset Pier should be
named after Harry C. Besse. Selectman Teitelbaum thought that the renaming of the
Onset Pier would be confusing to people since we already have a Besse Park and
people might thing the pier is located near the park. Selectman Slavin just had a
concern with changing the name only because of 5 million dollar grant that was
submitted and wasn't sure if the name change would affect that but it doesn't matter
either way. Selectman Tropeano stated that he believes that Harry Besse deserves
some type of recognition.

Present before the board: Bill Lockwood, Jacqui Hickey & Jean Connaughton from the Wareham Housing Authority to speak about the article submitted by CPC to construct 4 housing units. Also present is Sandy Slavin, Co-Chairman of the CPC Ms. Slavin stated that she did speak with Mr. Campinha regarding the sewer and he stated the reason they had problems in the past was due to roots growing in the system and he didn't have any concerns with the additional units. Selectman Teitelbaum explained that he is opposed to this because the Wareham Redevelopment Authority has an article coming before Town meeting to purchase some land and felt that the money could be used at that location to build more than 4 units. Selectman Tropeano stated that if they hold off any longer the cost to build the units would only increase and that project wouldn't be for some time down the road. Ms. Slavin explained that this is the 4<sup>th</sup> attempt to get this on the warrant and would like to have the voters decide.

The proposed route would leave from Hines/Lopes Field travel along Onset Beach to Onset Avenue, then to Nanumet and Camron Streets and terminate at the Bay Pointe golf course parking lot.
