Several residents came before the board to speak in favor of getting the streets in The neighborhood accepted.

10. 7:30 p.m. Dog Hearing –

MOTION: Selectman Tropeano moved to open the hearing. Selectman Teitelbaum seconded. Poll vote: Poll vote: Selectman Scarsciotti-yes, Selectman Bruce-yes, Selectman Teitelbaum-yes, Selectman Tropeano-yes, Selectman Slavin-yes.

MOTION: Selectman Teitelbaum moved to take administrative notice of the file. Selectman Tropeano seconded.

Attorney Bowen asked that anyone who will be testifying raise their right hand so that Town Counsel could swear them in.

Selectman Tropeano read into the record the complaint received from Cheryl Gorveatt-Dill, Wareham Animal Control Officer (as attached).

Selectman Teitelbaum explained that this is a continuation of the hearing and that going forward they will let the Crossman's speak first. He stated that the only complaint that can be discussed this evening is the ones in the letter from the Animal Control Officer and others cannot be discussed.

Present before the board: Sandra & Walter Crossman and Jennifer a certified dog trainer.

Ms. Crossman started out by saying they have hired a dog trainer to work with Dajsy for the past six weeks. She also stated that this was the first time in a year and a half that the dog got out of the yard and at no time was the dog running around the neighborhood. She said that on May 29, 2018 Daisy took advantage of the door not being properly latched and left the property in which she takes full responsibility for this action and her husband immediately went to get her. She said that she cannot walk her dog without people yelling at her to keep her dogs away as they are deemed dangerous. Ms. Gorveatt-Dill hand delivered to Ms. Crossman the following conditions on July 12th and asked that the dog be humanely restrained, the dog be confined outdoors in a securely enclosed and locked pen and when the dog is removed from the premises of the owner, the dog shall be securely and humanely muzzled and restrained with a chain not to exceed 3 feet and the dog only be walked by an adult of 18 years or older. She went on to say that she hasn't received any complaints since July 12th. The trainer explained that the dog has a good personality and she is a herding dog and she brought her dog over to the Crossman's and the dog never showed aggression towards her dog. Jennifer stated that when she first met Daisy she barked a lot and was very bossy and stated that her personality has changed since the training began and she does listen and is much more focused. Before the board was Christine DeCoursy who's dog was bitten by Daisy, she explained that she did take the dog to the Vet on the advice of the Animal Control Officer and that the dog was bit in the neck not in the ear as Mr. Crossman had stated earlier. Selectman Teitelbaum asked if the Crossman's reimbursed her for the vet bill, Mr. Crossman stated that one was never presented to him. Selectman Teitelbaum stated that the bill was for \$139.90. Before the board was Joseph Warshauer who witnessed the attack and stated that Daisy wasn't playing and went aggressively for the dog's neck. Mr. DeCourcy stated that the fence the Crossman's have is basically chicken wire. Selectman Tropeano asked if the Crossman's had their dog on a leash at the time and they indicated that they didn't and the dog is allowed to roam between the three houses. Before the board is Angela Didier who stated that Daisy has come after her on numerous occasions. Ms. Gorveatt-Dill stated that Angela Didier had called her on several occasions prior to this incident and expressed her concerns about the dog and mentioned that the dog has been off the property and she didn't want to file a complaint and she just wanted to make Animal Control aware of the situation. She stated that she went to the Crossman's property a couple of times and wasn't able to make direct contact with them and she did see the dog in the yard however, the dog didn't seem aggressive to her. Selectman Teitelbaum asked Ms. Gorveatt-Dill why would she deem the dog dangerous and not at risk, she responded that the dog inflicted injury to another animal unprovoked.

MOTION: Selectman Tropeano moved to close the public hearing. Selectman Bruce seconded. Poll vote: Selectman Scarsciotti-yes, Selectman Bruce-yes, Selectman Teitelbaum-yes, Selectman Tropeano-yes, Selectman Slavin-yes.

Selectman Teitelbaum asked Ms. Gorveatt-Dill if she was comfortable with the fence that the Crossman's had and she stated that she was not.

MOTION: Selectman Tropeano moved that the dog be humanely restrained and the dog be confined outdoors in a securely enclosed and locked pen and cannot leave the property unless accompanied by a controlling person over the age of 18 and on a leash not more than four (4) feet having a minimum tensile strength of three hundred (300) pounds, used in conjunction with a muzzle and must be microchipped. Selectman Bruce seconded.

11. TOWN BUSINESS

- a. Update from the Buzzards Bay Coalition re: Bathhouse Present before the board: Mark Rasmussen & Sam Grey Mr. Rasmussen stated that so far they have raised \$3 million for the bathhouse between government funds and private donations. They still have \$1.7 million to raise. Mr. Rasmussen stated that an RFP is out now for the rebuild of the stone pier on Wickets Island and also for rebuilding the staircase among other things to be done with the work to start at the end of September. Wickets Island will be safe and open to the public for next summer. They purchased 21 acres at Burgess Point which they have been doing a lot of improvements to clean up that forest area with all support from the Conservation Commission. They have added a float to the dock for the boats. Two months ago they added 50 acres of salt marsh at the head of Shellpoint bay. Mr. Rasmussen touched on the summer programs and working with the Gleason Family YMCA and the Boys & Girls Club. The Onset bathhouse rehab permits are in place and they are planning to break ground in September. He said that the roof is going to be 26 feet and the park is 28 feet leaving 2 feet to look out onto the water. The design is made to be able to look out over the building as well as over the cupola. The first floor would be designed for boat storage and the second story would be more designed for classes and the plan is to be able to use this year round.

I hereby make complaint hereon, that dogs owned or harbored by:

Sandra Crossman 198 Greatneck Rd Wareham, MA

Is a nuisance by reason of:

1. Vicious, disposition

On May 29, 2018 at around 5:00 PM Joseph Warshauer, 30 Lydia's Island Rd, reported that a dog owned or cared for by the residents of 198 Greatneck Rd, later identified as Sandra Crossman, attacked another dog, unprovoked and inflicted injury. The dog, owned by Christine DeCourcy, was later treated at Marion Animal Hospital for a couple of puncture wounds to the neck.

On May 22, 2018 I, Wareham Animal Control Officer Gorveatt-Dill received a complaint from angela Didler, of aggressive behavior by this same dog, described as a female, Australian Shepard, named Daisy, when running loose in the area of Lydia's Island. I spoke with Sandra Crossman about the complaint and was told the dog was in the process of professional training. Mrs. Crossman was made aware of the aggressive complaint and informed that if the dog was to have any future issues a dog hearing would be requested.

This complaint is made under the penalties of perjury.
