 applications and third would be scheduling of a joint board meeting.

Chairman Slavin spoke about Boston placing a ban on miniatures with any new liquor license; he also spoke about other towns and cities placing bans on plastic.

Mr. Sullivan suggested that the board review the short term rental bill local option. He feels this could coordinate with the Board of Health's rental inspection program.

Mr. Sullivan stated that Verilife is now renting the Tremont Nail Parking Lot from the town at \$2500.00 per month.

The Redevelopment Authority voted to set the monthly rate on the rental with Organa Brand at Tremont Nail, starting at \$15,000 per month then increasing to \$16,000 by the end of the 5th year.
