1. CALL MEETING TO ORDER BY CHAIRMAN

This meeting was held remotely due to COVID-19.

4. ANNOUNCEMENTS

Selectman Tropeano asked for a moment of silence for Dennis Damata who served as a police officer for the Wareham Police Department. He was also member of the Board of Selectmen and worked in the Board of Health Department at the Town Hall.

5. CITIZEN'S COMMENTS

Present before the Board: Sandy Slavin

Ms. Slavin stated that anyone completing the Census can drop it off in the payment box at the entrance of the Town Hall parking lot.

She also inquired about the due date for articles to be placed in the 2021 Spring Town Warrant. Selectman Teitelbaum stated that the Board will be voting on the Notice of Intent next week.

6. BOARD'S COMMENTS

Selectman Munise would like to discuss the policy for outreach meetings and the process of operating a cannabis business. Selectman Teitelbaum stated this would be discussed in further detail at next week's meeting.

9. DOG HEARING 7:15 P.M.

MOTION: Selectman Whiteside moved to open the hearing. Selectman Tropeano seconded. Roll Call: Selectman Slavin-yes, Selectman Tropeano-yes, Selectman Munise-yes, Selectman Whiteside-yes, Selectman Teitelbaum-yes.

VOTE: 5-0-0 (Unanimous)

Present before the Board: Joshua Kimball, Department of Natural Resources Officer and Christopher Lacky, owner of the dog, Chara.

Officer Kimball read into record the complaint letter.

Selectman Teitelbaum swore in all participants who will testify.

Officer Kimball explained that the circumstances involving this hearing is unlike past hearings because the person identified as Bonnie Lacky, Mr. Lacky's mother, who normally walks the dog, allows the dog to walk off leash. Due to a past medical condition, she doesn't truly understand the dog being off leash is a problem. Officer Kimball read into record three incidences involving attacks that were a result of letting the dog off leash. *(See attached)*

Officer Kimball also wanted to make clear that during all of the encounters with Chara, Mr. Lacky's dog, he was a very well-mannered and friendly dog and has never escaped the property. He reiterated that the problem is not with the dog, rather it is with Ms. Lacky who allows the dog off leash.

Selectman Teitelbaum asked the Board if they had any questions. Selectman Whiteside asked if the dog was up to date with his shots. Officer Kimball stated at the time of the first incident he was not because Mr. Lacky had just moved into Town. Shots and vaccinations were up to date at the time of the other two incidents. Selectman Whiteside also asked Mr. Lacky to describe the leash used to walk Chara. Mr. Lacky described the leash as a military type leash with a locking mechanism. Selectman Teitelbaum then asked Mr. Lacky if he agreed to the report given and to verify that the facts presented are true. Mr. Lacky responded yes. He stated that Chara is a family dog who is very large and when he is playful or in a protective

mode, he can cause damage. He also stated that he has reached out to each individual from each incident.

Officer Kimball recommended deeming the dog at risk with the following restrictions:

1. Prohibiting Bonnie Lucky from walking the dog; 2. The dog is to be muzzled at all times while off property; 3. The dog is to be walked by an adult 18 or older.

Mr. Lucky agreed to the restrictions and stated that the restrictions have started being followed. He also stated that he has explained the restrictions to his mother and the reasons why these restrictions must be enforced and said she appeared to understand the matter at hand.

MOTION: Selectman Whiteside moved to close the hearing. Selectman Tropeano seconded. Roll Call: Selectman Slavin-yes, Selectman Tropeano-yes, Selectman Munise-yes, Selectman Whiteside-yes, Selectman Teitelbaum-yes.

VOTE: 5-0-0 (Unanimous)

MOTION: Selectman Whiteside moved to deem the dog at risk for two years with the following restrictions: 1. Bonnie Lucky is prohibited from walking the dog; 2. The dog is to be muzzled when taken off property; 3. The dog is to be walked by an adult 18 years of age or older using the leash described by Mr. Lucky. Selectman Slavin seconded. Roll Call: Selectman Slavin-yes, Selectman Tropeano-yes, Selectman Munise-yes, Selectman Whiteside-yes, Selectman Teitelbaum-yes.

VOTE: 5-0-0 (Unanimous)

10. TOWN BUSINESS

a. COVID-19 Update.

Mr. Sullivan stated that there are 100 new confirmed cases since January 17th, 1043 cases since March, and 13 deaths within the last six weeks.

b. Trash disposal update.

Transfer Station stickers can now be purchased in person at the Municipal Maintenance Department Monday through Friday from 8-3. Home Depot has reached out to sell bags and CVS has received their shipment of bags to purchase for the Transfer Station. Notices will be going out this week to residential property owners with information on Curbside pickup and the transfer station.

Anyone having a hard time signing up or opting out of curbside pickup online can go to the chat function.

Is a danger and nuisance to the public by reason of:

1. On January 2nd 2020, Chara was allowed off leash by Bonnie Lacky and attacked a small dog resulting in only emotional distress. Case number 20-11-OF

2. On February 24th 2020, Chara was allowed off leash by Bonnie Lacky and attacked a small dog resulting in only emotional distress. Case number 20-304-OF

3. On November 7th 2020, Chara was allowed off leash by Bonnie Lacky and attacked a small dog resulting in physical injuries to both the victim dog and its owner, as well as emotional distress. Case number 20-1725-OF

I request a dangerous dog hearing to be scheduled before the Board.

On Saturday November 7th 2020 at approximately 8:45pm, I Officer Joshua Kimball of the Wareham Department of Natural Resources received a phone call from a party identified as Susan Callow DOB 02/06/1965 of 6 Cromesett Rd, Apartment #16 reporting that her dog had been attacked by an unleashed dog, and she was also injured as a result. CALLOW stated that she was walking on the premises of her apartment complex with her dog Ozzy, a male beagle and Ozzy was leashed. An unknown to her female was walking a gray pitbull type dog and it was off leash, and ultimately had attacked Ozzy. CALLOW stated to me that she has been having back problems and just recently had 2 MRI's done to find out the issue with her back, and when she was trying to separate Ozzy from this other dog she fell on her back and potentially had injured herself even more. Additionally, CALLOW stated to me that she has a scraped and bruised left knee. CALLOW stated that she had tried to get the woman's information, but she could only say "stroke, stroke". CALLOW stated that the woman was sitting behind the Cromesett Woods sign for a while, and then had fled the area walking down Cromesett Road. When CALLOW told me that the woman could only say "stroke", I immediately knew who the offender was as I have had previous dealings with this dog, and her in the past. The female is Bonnie Lacky DOB 03/03/1961 and resides at 153 Cromesett Rd. B.LACKY lives with her son, Christopher Lacky DOB 01/11/1981 at 153 Cromesett Road. The dog's name is Chara, a gray American Staffordshire Terrier. B. LACKY had a stroke previously, and she has suffered from the effects of that ever since. In my prior dealings with B. LACKY, she has a very hard time communicating and understanding the severity of certain things.

CALLOW stated that she was going to be bringing her dog to the Cape Cod Veterinary Specialists for treatment. CALLOW stated that Ozzy sustained injury to his right front leg, on the body area. There was a deep laceration with potential for muscle and nerve damage. CALLOW stated that Ozzy would be going in for surgery on 11/08/2020 in the morning.

On 11/08/2020 I called CALLOW back to see the status of Ozzy. CALLOW stated that Ozzy was going to be going into surgery at 10:00 to repair his wounds. I asked CALLOW how she was feeling, and she stated that "she did not realize how bad she would have felt the next morning" and that she was in an excruciating amount of pain. CALLOW also expressed to me that she has no family members and that Ozzy is the only thing she has and is very upset at this situation. I advised CALLOW that I would be reaching out to the dog's owner today, and I further explained the situation that the LACKYS are in in regards to B. LACKY's previous history with our Department. CALLOW was asking me how to receive compensation from the LACKYS in regard to this incident, and I advised her that is a total civil matter that we would not be handling. I made CALLOW aware that this is now the 3rd bite report that we have had due to B.LACKY having Chara off leash while walking with him. I advised CALLOW that we would be having a dangerous dog hearing with the Board of Selectmen, and that she would be notified of same. Additionally, CALLOW was told that B. LACKY would be receiving a citation for not having the dog on a leash, and the dog being unlicensed. I told CALLOW to call us back at anytime, and that I would be calling later to check in on Ozzy's condition.

After I got off the phone with CALLOW, I called C. LACKY and explained the situation to him. He was very remorseful that this has happened again, and this time resulted in severe injury. C.LACKY stated that B.LACKY has recently been walking to the liquor store at the end of the road and consuming alcohol prior to returning back to the residence as he does not allow her to drink at the residence. I advised C.LACKY of the quarantine process for Chara and that we would be going forward and requesting a dangerous dog hearing with the Board of Selectmen as this was now the 3rd time this has happened. C.LACKY has asked me to come to his residence tomorrow 11/09/2020 and speak with him and his mom to go over this so that she can understand the severity of her actions letting Chara off leash. A supplemental report will be written after that occurs. I told C.LACKY that my recommendation to the Board of Selectmen will be to order his mother to never walk the dog again, as we have had no other previous complaints of his dog being off leash or attacking any other dog unless it is being walked by B.LACKY. I also told C.LACKY that the only reason why I would do this is because Chara is a good dog, as I have met him a few times and that the actions of B.LACKY are setting Chara up for failure. If we eliminated B.LACKY from walking Chara, there should be no future issues

Letter dated February 25th 2020 to C.LACKY outlined recommended guidelines of safety restrictions for Chara which included muzzling of Chara, and securely restraining by use of leash in hand when removed from the property and when on the property, confined in accordance with MGL Chapter 140 Section 174E. Enclosed in the Department file is a copy of all previous reports that the Plymouth Animal Control has responded to at the LACKYS previous residence in their Town.

As a result of this incident, B.LACKY will be cited for loose dog, subsequent offense.
A Dangerous Dog Hearing will be scheduled in accordance with MGL Chapter 140 Section 157 and a recommendation to the Board for ordering B.LACKY to not walk the dog any longer will be made.

Dear Bonnie and Christopher,

In the calendar year 2020, the Department of Natural Resources has responded to 3 total dog bite incidents involving Chara being walked by Bonnie. The latest one to occur was on November 7th at 4:30pm at 6 Cromesett Road. The victim dog and its owner both suffered severe injury to themselves as a result of Chara being allowed off leash.

Incident #1 – January 2nd 2020 - Call # 20-189 – Report number 20-11-OF

Incident #2 – February 24th 2020 - Call # 20-7085 – Report number 20-304-OF

Incident # 3 – November 7th 2020 – Call #20-39762 – Report number 20-1725-OF

It is my impression that Chara is a friendly dog towards humans, however he is being led down the wrong path by being allowed off-leash by Bonnie. As a result we will be going forward with having a Dangerous Dog Hearing before the Board of Selectmen pursuant to MGL Chapter 140 Section 157. My recommendation to the Board will be that Bonnie is no longer allowed to walk Chara at all and that Chara be muzzled when walked off of the confines of your property.

You will receive notice from the Board of Selectmen in regards to the hearing date. It will be hand delivered by an Officer of this Department, or the Wareham Police Department.

Chara is under quarantine between the dates of November 8th until November 18th due to the dog bite. Chara shall not be removed from the property at any time during this quarantine period. Failure to comply with an Order of Quarantine may result in a fine of \$500 or imprisonment in accordance with the law. If you have any questions, please feel free to reach out to me.

Dear Mr. Lacky,

On 02/25/2020 an Officer of this Department received complaint of a dog owned by you. This particular incident involved your dog Chara, who was off leash being walked by your mother Bonnie Lacky. As a result of Chara being off leash, he entered the property of another person and attacked their dog unprovoked causing injury to their dog.

As a result of this incident, this Department is putting the following safety restrictions on your animal.

1. When Chara is removed from the premises of 153 Cromesett Road, the dog shall be securely and humanely muzzled and restrained with a chain or other tethering device having a minimum tensile strength of 300 pounds and not exceeding 3 feet in length.
2. When Chara is kept on your property outside of the dwelling that he be confined to a kennel or secure enclosure that meets the requirements of MGL Chapter 140 Section 174E, or other secure tethering device in compliance with the provisions of MGL Chapter 140 Section 174E

These 2 listed restrictions are voluntary, however if another incident occurs where your dog is found to be off leash, in violation of any Mass General Law of Town of Wareham By-Law regarding Dog Control or in the event of another bite, we will hold a Dangerous/At-Risk Dog hearing with the Wareham Board of Selectmen where they will place mandatory restrictions on Chara pursuant to MGL Chapter 140 Section 157 and other provisions of the Town of Wareham Dog Control By-Law where applicable.

Currently, we have requested information from the Town of Plymouth to determine if a prior order of Dangerous/Nuisance Dog by their hearing authority has been issued before. If such order has been issued, the order is valid throughout the Commonwealth of Massachusetts and this Department will enforce the provisions listed in it. If such order was issued by the Town of Plymouth, we will move forward with a new hearing in the Town of Wareham.

As a result of this most recent bite, you have been issued a written warning for having an unlicensed dog in the Town of Wareham. Dog licensing is required by state law. Please go to the Town Clerks Office and license your dog immediately to be in compliance with the law. Additionally, a written warning will be issued to your mother Bonnie, for allowing Chara to be off leash.

This is Chara's second incident in the Town of Wareham within the last 2 months. We responded to a 911 call of a woman and her dog being bitten at 6 Cromesett Road on 01/02/2020 where your mother was walking Chara on leash.



NARRATIVE FOR DNR JOSHUA KIMBALL

On 01/02/2020 at approximately 4:25pm, I Officer Joshua Kimball of the Wareham Department of Natural Resources was dispatched to a reported dog bite on Cromesett Road. The reporting party was stating that one of the parties was fleeing on foot from the incident location. I arrived on scene shortly after and located the party that was fleeing at the entrance to Cromesett Woods at 6 Cromesett Road. Director Buckminster went to where the bite victim was located with Wareham EMS inside of the complex at 6 Cromesett Road. The party was having a hard time speaking and pronouncing words and answering questions due to a preexisting medical condition which she told me that she had a stroke. After numerous attempts to identify the female, she provided me with her Massachusetts ID card. The party was identified as Bonnie Lacky DOB 03/03/1961. I asked LACKY what had happened, and she told me that the dogs were OK. I asked if the dog she was walking, a gray pitbull named Chara was OK and she said there was no problem. I asked LACKY if the dog was up to date on its shots and she said "yes dog go to vet" I asked where LACKY resides as her address on her license says that she lives in Ellisville. She had a hard time answering my question and used her finger to display numbers of 143. I asked her what road and she pointed down the street on Cromesett Road she said yes. LACKY then told me that this dog was Christopher's dog. I asked who Christopher was and she kept saying Christopher. A search of the in-house records shows Christopher Lacky to live at the same address as B.LACKY in Ellisville. The animal was quarantined at 143 Cromesett Road, and LACKY was served the paperwork in hand.

Next I went to where the victim was located in the complex to meet with Director Buckminster and EMS. The victim was identified as Nancy Bolinder DOB 12/14/1952. BOLINDER was walking a small older gray terrier mix named Jumbo. BOLINDER had a small laceration to her left index finger. BOLINDER stated that LACKY's dog had its entire mouth over Jumbo's head. I inspected Jumbo and there were no cuts, scratches or abrasions on the dog that I could see. BOLINDER was highly emotional during the time I was asking her questions. She was asked by EMS if she wanted to go to the hospital, but she declined. I advised BOLINDER that the dog would be under quarantine period to make sure it did not have rabies. Myself and Director Buckminster assisted BOLINDER into her apartment, and got her settled in and calmed down.

Later in the evening, BOLINDER was at the Tobey Hospital Emergency Room seeking treatment for the bite. I spoke with the nurse in charge and advised her of the situation. The nurse asked if the dog was up to date on its shots, and if the dog was quarantined and I told her that the keeper of the dog told me it was up to date but I have no confirmation but I did confirm that the dog was in fact quarantined.

On 1/4/2020 I searched the records for 143 Cromesett Road and could not find such address in the assessors database. Google Maps also shows the address to be woodlands. I contacted Plymouth Animal Control to go to

On 02/24/2020 at approximately 3:00pm I, Officer Joshua Kimball of the Wareham Department of Natural Resources received a call from Penny Hennrikus DOB 04/17/1964 of 100 Cromesett Road, Wareham. HENNRİKUS wanted to report a dog bite that had occurred on her property. I asked HENNRİKUS to explain what took place, she stated that a gray pitbull was loose and came running up her driveway, went around into the backyard of her house and pinned her dog to the ground. HENNRİKUS stated that she had her 2 dogs in her backyard, but only one of them was bitten by the gray pitbull, later identified as Chara, a gray male American Staffordshire Terrier owned by Christopher Lacky DOB 01/11/1981 of 153 Cromesett Road, Wareham. HENNRİKUS' dog that was injured during the incident was a 12 year old male brown and white Jack Russell/Rat Terrier mix named Ziggy. HENNRİKUS stated that Ziggy was pinned to the ground by Chara at the throat. HENNRİKUS heard the person who was walking Chara yelling for the dog. The person who was walking CHARA was identified as Bonnie Lacky DOB 03/03/1961 of 153 Cromesett Road, Wareham. B. LACKY is C. LACKY's mother. Through joint efforts of all parties, the 2 dogs were separated, and B. LACKY had left the property with Chara. I asked HENNRİKUS to describe any injuries to her dog, and she stated that there were none that she could see immediately, but that she would check in the morning after Ziggy had calmed down. I asked if her other dog was injured at all and she stated not physically, but emotionally. HENNRİKUS' other dog is a black and white purebred female Rat Terrier named Happy. Both of HENNRİKUS' dogs are up to date on rabies vaccines according to HENNRİKUS.

I explained the quarantine process and law for the biting dog to HENNRİKUS, and also advised her to call back with any update on her dogs condition. HENNRİKUS was also told to call back with any future issues with Chara.

At approximately 3:53pm, I arrived at C. LACKY's address to make contact with someone in regard to the dog bite incident. A juvenile answered the door, and I had asked if B. LACKY was home. The juvenile stated that she was out for a walk. I left him a door hanger and asked him to have someone call me when an adult came home. Shortly after I left the residence, Police Dispatch received a call from C. LACKY and wanted a call back. I called C. LACKY and explained what had happened. C. LACKY stated that he had told his mom multiple times that the dog needs to be on a leash, but due to an existing medical condition that she has, sometimes she is not able to process and understand things. I asked C. LACKY if he was made aware of the incident that occurred 01/02/2020 involving his dog Chara and B. LACKY. (Refer to call number 20-189 and report number 20-11-OF) C.LACKY stated that B. LACKY never had told him about that incident. C.LACKY stated that he would reach out to the owner of the dog that was injured and offer to pay for any veterinarian bills as a result of this incident. C. LACKY went on to state that his dog is not aggressive, but gets very overly excited about seeing smaller animals and due to his size and breed people assume him to be aggressive. I explained to C. LACKY that this is now the second incident that has occurred in Wareham and we would be issuing written warnings to him for having the dog not licensed with the Town as required by law. A written warning will also be issued to B.LACKY for having Chara off leash. C. LACKY was also told that we will issue a voluntary compliance order to avoid any future issues with Chara, and if another incident occurs where the dog is found to be in violation of the Town by-laws, the voluntary order or has another dog bite incident that we will move forward with a hearing in front of the Board of Selectmen. C. LACKY was made aware of the quarantine process as well.
