The Wareham Middle School is located at 7 Viking Drive, Wareham, MA. The District will be responsible for the payment of all costs incidental or related thereto, and for which the town of Wareham may be eligible for a grant from the Massachusetts School Building Authority (MSBA), said amount to be expended under the direction of the Wareham School Building Committee. To meet this appropriation the [the District will pay from revolving account(s) \$95,000.

Wareham acknowledges that the MSBA's grant program is a non-entitlement, discretionary program based on need, as determined by the MSBA, and any costs which Wareham incurs in excess of any grant approved by and received from the MSBA shall be the sole responsibility of the District. Selectman Slavin seconded. Roll Call: Selectman Slavin-yes, Selectman Munise-yes, Selectman Tropeano-yes, Selectman Whiteside-yes.

located at 4 Viking Drive, Wareham, Ma. The District will be responsible for the payment of all costs incidental or related thereto, and for which the town of Wareham may be eligible for a grant from the Massachusetts School Building Authority (MSBA), said amount to be expended under the direction of the Wareham School Building Committee. To meet this appropriation the District will access \$75,000 from revolving accounts(s). Wareham acknowledges that the MSBA's grant program is a non-entitlement, discretionary program based on need, as determined by the MSBA, and any costs which Wareham incurs in excess of any grant approved by and received from the MSBA shall be the sole responsibility of the District. The revitalization of Merchants Way has secured a \$50,000.00 grant.
