#### 9. TOWN BUSINESS

a. Discussion & actions relating to FY 2020 MA CDBG Grant.

Present before the Board: Peter Sanborn, Community Development Programs Manager

Mr. Sanborn went over the FY2020 Mini-Entitlement Plan Grant application and is looking to recommend the following:

Wareham Housing Rehabilitation Program - \$225,000.00

Public Improvements/Onset - \$212,000

Public Social Services (up to 5) - \$165,000

Program Delivery & General Admission - \$223,000.00

**MOTION:** Selectman Teitelbaum moved to approve the filing of the FY2020 Massachusetts CDBG program grant application in the amount not to exceed \$825,000 and to authorize the Chairman of the Board of Selectmen and Town Administrator to take all actions required relating to the submission of said grant application; and to designate Derek Sullivan, Town Administrator, as Environmental Certifying Officer, with such designation in effect for the next year. Selectman Slavin seconded.

b. Discussion & vote on the accelerated repair program for the MS roof and HVAC.

Present before the Board: Kim Shaver-Hood and Joyce Bacchiocci Ms. Shaver-Hood is asking for an approval to submit a statement of interest to the Massachusetts School Building Authority for accelerated repair on the Middle School HVAC as well as the High School HVAC. She stated that the cost for fiscal year 2019 and 2020 between the two schools was \$131817.00 in repairs and it has been an ongoing problem due to poor conditions. The accelerated repair would take care of these concerns and if it is approved, it may take the MSBA to respond by spring of next year. Selectman Slavin's concern was this was not mentioned in the Capital Planning report. Mr. Sullivan stated that there will be a Capital Planning meeting to attend and bring it up.

**MOTION:** Selectman Bruce moved to approve the accelerated repair program for the MS roof and HVAC. Selectman Munise seconded.

**MOTION:** Selectman Bruce moved to authorize the statement of interest vote: resolved: having convened in an open meeting on January 28, 2020, prior to the SOI submission closing date, the Board of Selectmen of Wareham, in accordance with its charter, by-laws, and ordinances, has voted to authorize the Superintendent to submit to the Massachusetts school Building Authority the Statement of Interest Form dated 2/14/20 for the Wareham Middle School located at 4 Viking Drive, Wareham which describes and explains the following deficiencies and the priority category(s) for which an application may be submitted to the Massachusetts School Building Authority in the future. Selectman Munise seconded.

**MOTION:** Selectman Bruce moved to authorize the statement of interest vote: resolved: having convened in an open meeting on January 28, 2020, prior to the SOI submission closing date, that Board of Selectmen of Wareham, in accordance with its charter, by-laws, and ordinances, has voted to authorize the Superintendent to submit to the Massachusetts School Building Authority the Statement of Interest Form dated 2/14/20 for the Wareham High School located at 7 Viking Drive, Wareham which describes and explains the following deficiencies and the priority category(s) for which an application may be submitted to the Massachusetts School Building Authority in the future. Selectman Munise seconded.

  - d. Discussion & vote on proposal to change name of Board of Selectmen to Wareham Select Board.

Selectman Slavin stated that the Massachusetts Selectmen's Association officially changed their name to the Massachusetts Selectboard Association and they are asking individual towns that have Board of Selectmen to change the name as well. It is not required, it is the decision of the Board.

**MOTION:** Selectman Munise moved to discuss changing the name of the Board of Selectman to Wareham Selectboard. Selectman Teitelbaum seconded.

Selectman Teitelbaum stated that he doesn't see a need to change the name because the Board has been the Board of Selectmen since 1839 and does not want to see this tradition change.

Selectman Munise stated that with the change, it becomes gender neutral and it is politically correct.

e. Discussion and vote on articles for Spring Town Meeting.

**MOTION:** Selectman Bruce moved to include the Wareham School Committee article re: Transfer of the John William Decas Elementary School located at 760 Main Street, Wareham. Selectman Teitelbaum seconded.

VOTE: 5-0-0 (Unanimous)

Joyce Bacchiocchi was present before the Board to explain the article to change the new elementary school located at 63 Minot Ave. to Wareham Elementary School. She explained that Decas and Minot Forest Elementary are being combined into one school and by changing the name, it brings both schools together. Referencing the names of Decas and Minot Forest will be included within the school in some way.

**MOTION:** Selectman Slavin moved to not include the Wareham School Committee article re: Naming of the New Elementary School located at 63 Minot Avenue, Wareham, MA. Selectman Teitelbaum seconded.

4-0-1 (Selectmen Munise abstained)

**MOTION:** Selectman Slavin moved to authorize the placement on the warrant of the article re: making the position of Town Clerk an appointed position rather than an elected position with the inclusion of a preface to be written by Town Counsel that the Charter changes be obtained by a petition for Special Legislation. Selectman Teitelbaum seconded.

**VOTE:** 5-0-0 (Unanimous)

**MOTION:** Selectman Slavin moved to authorize the placement on the warrant of the article re: to amend the Charter Section 3-1 (a) to add the words 'Sewer Commissioners' after the words, 'a board of assessors' with the inclusion of a preface to be written by Town Councel that the Charter changes be obtained by a petition for Special Legislation. Selectman Teitelbaum seconded.

**VOTE:** 5-0-0 (Unanimous)

**MOTION:** Selectman Slavin moved to authorize the placement on the warrant of the article re: to amend the Charter Section 3-9 Board of Road Commissioners by striking it in its entirety with the inclusion of a preface to be written by Town Counsel that the Charter changes by obtained by a petition for Special Legislation. Selectman Teitelbam seconded.

**VOTE:** 4-1-0 (Selectman Munise opposed)

f. Appointment of Town Counsel.

Appointment of Town Counsel will take place in March.

### 11. TOWN ADMINISTRATOR'S REPORT

Mr. Sullivan stated that the rebranding effort has launched and went out to the media and said this is not replacing the gateway. The rebranding effort is to point out all of the good things the community of Wareham has to offer.

### 12. <u>LIAISON REPORTS/INITIATIVE REPORTS</u>

Selectman Slavin attended the MMA event. The discussions included updates on the policies for the Massachusets transportation system, the Massachusetts Tobacco Control Technical Assistance Program, and updates from the ABCC. (attachment)

The Onset Bay Center had a presentation at Glen Cove and provided tour of the Onset Bathhouse.

Selectman Munise attended the Planning Board meeting and they voted to approve and endorse the Master Plan.

Selectman Teitelbaum stated the Charter change from last year has made it through the House and Senate and is currently waiting to be signed by the Governor. Once received, the time frame for submitting warrant articles will be expanded.

Selectman Tropeano attended the Sewer Commissioners meeting with the Town of Bourne and discussed the outflow plan. At present, no official votes have taken place.
