### Program Highlights

- For communities with MBTA service and others
- Wareham is classified as 'MBTA-Adjacent' and is included in the program
- ത • Must have zoning that allows multi-family housing as-of-right, at density of at least 15 units/acre [townhouses], within % mile of a transit station, no age restrictions and suitable for families with children
- And that could build out in numbers equal to 10% of existing housing
- Wareham is calculated as needing capacity for 1297 MF units based on 12,967 units in 2020 census

## Looks Like We Are Covered

- Wareham has CG zoning
- Multi-family buildings [5+ units] are allowed as of right [Zoning Bylaw **Table 320**]
- Density is 5,000 SF for first unit, and 1,000 SF for each additional unit; equivalent to **39 units/acre** [Zoning Bylaw Table 627]
- No age restrictions
- Within a ½ mile of the downtown T platform
- Initial calculations show capacity for 2,000+ units


- An allowance for a business logo, the business name, in a sans serif font, and a block for a directional arrow is suggested

- They must be approved by the Board of Selectmen as signs in the town ROW.




