4. ANNOUNCEMENTS

The American Legion Post members of Wareham Post 220 are planning to conduct their annual Poppy Drive for this Independence Day from July 1st through July 5th. The funds received will be used to support local Legion programs.

The Summer of Love Concert Series will be held at the Onset VFW Pavilion every Wednesday from 6:30 pm - 9:00 pm beginning June 23^{rd} through August 25^{th} . Reserve a table up to eight or bring your own chair. All shows will feature comedian Tom Stewart.

There are several openings on boards and committees. Applicants are asked to review the Committee Handbook which contains a description of what the committee does which can be viewed online. A very impressive list. The entire class was awarded more than \$229,000.00 in scholarship money.

Chairman Whiteside wanted to recognize one very special graduate of the class of 2021: a gentleman who left school at the age of 17 to serve his country during WW II by joining the United Sates Navy. John F. Fearing was awarded his diploma on June 5th, at age 94. When asked what his plans are he quipped he might go to college. Chairman Whiteside also thanked him for his service to the country, and congratulated him on receiving his Wareham High School diploma.

Valedictorian, Adreanna Dillen, who ran track for ORR because Wareham could not field a team, said the following in her speech, "Spending time on another school's team made me appreciate where I come from. I've spent a lot of time trying to figure out what makes Wareham so different from other communities. I just can't think of any other words to describe it besides HOME or FAMILY."

5. <u>CITIZEN'S COMMENTS</u>

Present Before the Board: Don Jepson

Mr. Jepson asked that the Board address why a significant amount of funds were assigned to the Littleton Drive 40b project when 40b projects have been discouraged in the past. He also suggested that citizens in Town be provided a summary of what the Town has received concerning solar plans.

6. BOARD'S COMMENTS

Selectman Munise suggested formalizing a Solar Bylaw Committee and have it as either a Board appointed committee or part of the Zoning Review Committee that involves regular meetings and meeting minutes. He also suggested the Solar Bylaw be completed by the Fall or Spring.

Selectman Slavin talked about the issues with trash being left on the side of roads as well as issues with signs on Town Property. He reminded citizens that signs should

not be nailed to trees or utility poles and any yard sale signs that are displayed must be taken down after the sale is over.

7. <u>7:15 P.M. – DOG HEARING</u>

MOTION: Selectman Tropeano moved to open the hearing. Selectman Whiteside seconded. Roll Call: Selectman Whiteside-yes, Selectman Tropeano-yes, Selectman Slavin-yes, Selectman Munise-yes, Selectman Teitelbaum-yes.

VOTE: 5-0-0 (Unanimous)

Present before the Board: Cheryl Gorveatt-Dill/Animal Control Officer; Mr. Thomas Worthen; Mr. Lawrence Edwards; Mrs. Nancy Edwards. Not present: Mr. John Reidy

Ms. Gorveatt-Dill read the complaint letter into record. (See attached)

Selectman Teitelbaum swore in all participants testifying.

Ms. Gorveatt-Dill stated that the dog owners have been very reasonable and considerate and making efforts to improve the situation. Their efforts have been unsuccessful and problems with the dogs continue. They are not dangerous or vicious and the complaints have involved the dogs being loose and found on the beach, on properties, on the golf course, and now on a federally protected area with piping plover. Mr. Worthen stated that his brother in law, Mr. Reidy has Alzheimer's and at times will open the door to let the dogs out. He also stated that in the last five weeks, to the best of his knowledge, the dogs have only been loose once. Mr. Lawrence was before the Board and stated that he filed a complaint the week prior to the meeting and the dogs were on his property the day before the meeting. Mrs. Lawrence stated that this has been an ongoing problem for more than three years. Ms. Gorveatt-Dill requested that the dogs be deemed a nuisance and requested that the Board order Mr. Worthen and Mr. Reidy to take remedial action to ameliorate the cause of the nuisance behavior per M.G.L. Chapter 140 sec. 157.

MOTION: Selectman Tropeano moved to deem the dogs a nuisance and to continue the dog hearing in sixty days. If there are no complaints or citations issued within the sixty days, the Animal Control Officer has the authority to cancel the hearing at her discretion. Selectman Whiteside seconded. Roll Call: Selectman Whiteside-yes, Selectman Tropeano-yes, Selectman Slavin-yes, Selectman Munise-yes, Selectman Teitelbaum-yes.

Discussion ensued regarding the Liquor Locker reopening their establishment after being closed due to a fire without the Certificate of Occupancy being filed. Attorney Bowen recommended the Building Official handle this in the ordinary course of business and suggested inviting Liquor Locker to the next meeting. Should there not be a good explanation for delay or non-compliance, disciplinary proceedings can be considered. *Ranchod, Inc. did not attend the meeting as requested.*

Mr. Kjelgaard explained that Scarlet Rose is a wine bar with a very limited food menu. Craft beers, soda, coffee and tea will be offered as well. There will not be a full kitchen or grill and there will be some entertainment. Concerns from the Board included limited space for deliveries and the use of Center Street because of the high volume of traffic. The application will be amended to reflect a new business plan.

Trade Winds is going to have an exclusive arrangement with Trade Routes which is a cannabis product manufacturer, cultivator and soon to be retailer.

In addition, the Board would send a letter to the ABCC advising them of the finding and what the vote was. Selectman Teitelbaum asked to see the tips certification. Selectman Munise requested more information pertaining to the amount of ounces given in the samples and what the maximum amount of samples would be given to each patron.

MOTION: Selectman Teitelbaum moved that the issuance of free beer samples would promote business and is not a retail activity that would interfere with other retail licenses subject to a Tips Certificate, a business outline explaining the detailed plan of samples given and the maximum amount. Selectman Slavin seconded.

The Wareham Department of Natural resources has had countless complaints on the two dogs owned or cared for by the above named parties. We have given warning, written citations, and had endless conversations with the dog owners to no avail. The two dogs in question, Coco, described as a standard poodle and Rocky, described as a golden retriever, have wreaked havoc on the surrounding neighbors and often people located at Little Harbor Beach. We have even received complaints that these dogs have been seen in the location of the protected Piping Plover. Our Department has attempted to work with the dog owners, offering numerous suggestions on how to contain the dogs and resolve the matter without success.



Dear Attorney Sheehan,

I have been authorized by a vote of the Board of Selectmen to respond to your Open Meeting Law complaint dated May 24, 2021.

In your complaint you assert that it is a violation of the Open Meeting Law for the Selectmen Chairperson to regulate the "Public Comments" section of the Board agenda by not recognizing litigants actual or threatened. I note, parenthetically, that you are an attorney representing actual litigants who are suing Wareham, and that you have threatened other litigation against the town.

Your complaint is unfounded. The question of whether we may choose whom to recognize at our meetings is well settled, and the Attorney General has over the years rejected similar complaints against municipalities. More recently, the Attorney General rejected the exact same complaint that you now make in a determination dated May 21, 2021, a copy of which is attached hereto for your review. It supplies the particulars of the legal precedents and in it the Attorney General explains why your complaint fails to state a claim.

> Open Meeting Law Complaint RE:

Dear Mr. Teitelbaum:

This office received a complaint from Lisa Morales on April 21, 2021¹, alleging that the Wareham Board of Selectmen (the "Board"), and specifically you, violated the Open Meeting Law, G.L. c. 30A, §§ 18-25. The complaint was originally filed with the Board on March 23, and you responded by email on April 5.2 The Complainant alleges that she was not permitted to participate during the public comment portion of the Board's March 23 meeting.³

Following our review, we resolve this matter by informal action in accordance with 940 CMR 29.07(2)(a), and find that the Board did not violate the Open Meeting Law. In reaching this determination, we reviewed the Open Meeting Law complaint, the response, the request for

³ The complaint also alleges that on February 16 the Board "banned" the Complainant from public comment. We decline to review this allegation as it was not timely filed with the Board. To be considered timely, a written Open Meeting Law complaint setting forth the circumstances which constitute the alleged violation must be filed with the public body within 30 days of the date of the alleged violation, or if the alleged violation could not reasonably have been known at the time it occurred, then within 30 days of the date it should reasonably have been discovered. G.L. c. 30A, § 23(b); 940 CMR 29:05(4). Because the Complainant was aware on February 16 that she was not permitted to participate in public comment on that day, any complaint regarding this allegation should have been filed no later than March 18.

further review, and a video recording of the Board's March 23 meeting.⁴ During the "Citizen's Comments" portion of the Board's March 23 meeting, the Chair⁵ refused to allow the Complainant to speak while allowing other members of the public to speak. The Open Meeting Law states that "no person shall address a meeting of a public body without permission of the chair, and all persons shall, at the request of the chair, be silent." G.L. c. 30 A, § 20(f). The Open Meeting Law therefore gives discretion to the chair of a public body to determine who may speak or otherwise participate at a meeting. See OML 2017-154; OML 2014-23; OML 2013-64; OML 2012-59.⁶ Because the Open Meeting Law gives the chair of a public body discretion over who may speak or otherwise participate at a meeting, we find no violation with respect to this allegation. Although public comment is within the chair's discretion, we encourage public bodies to allow for as much public participation as time and circumstances permit. See OML 2015-12; OML 2014-129; OML 2012-59.

We now consider the complaint addressed by this determination to be resolved. This determination does not address any other complaints that may be pending with our office or the Board. Please feel free to contact the Division at (617) 963-2540 if you have any questions regarding this letter.

At the May 18, 2021 regularly scheduled meeting of the Wareham Board of Selectmen, the Chair denied a member of the public the opportunity to speak during the "Citizen's Comments" section of the Board's agenda. "Citizen's Comments" appears on the May 18, 2021 agenda as Item 5 and is a regular part of the Board's weekly agenda for members of the public to address the Board on any topic. The meeting was held by Zoom. Town Counsel was present. On May 12, 2021, a group of Wareham residents filed an administrative appeal to the Massachusetts Department of Environmental Protection (MassDEP) seeking a "Request for Denial-Superseding Order of Conditions" under the Massachusetts Wetland Protection Act ("Wetlands Act"). (DEP File No. SE76-2611) (DEP Appeal). The right to appeal is provided by the Wetlands Act to persons aggrieved by a conservation commission order of conditions. A group of ten or more residents may appeal as a "Ten Residents Group." The DEP Appeal was brought by thirteen residents of the Town of Wareham (soon to be fourteen with the addition of a member of the Mashpee Wampanoag community) ("Ten Residents Group").

At the May 18, 2021 meeting, a member of the Ten Residents Group raised a hand on Zoom seeking to speak during the Citizen's Comments portion of the agenda. The member did not identify the topic they intended to raise.

Without knowing the topic, Board Chair Whiteside denied the member the opportunity to speak. She cited an alleged Town "policy" preventing anyone "who threatens to sue the Town" or who "is suing the Town" from addressing the Board during public comment. A discussion among the Board and Town Counsel followed at the meeting. A majority of the Board and Town Counsel of the Board and agreed with this alleged Town "policy" refusing the Ten Resident Group member the opportunity to address the Board. The Town has the state of the Town or who is challenging any decision of any Town official, board or committee is banned from addressing the Board on any topic whatsoever during "Citizen Comment."

The Board's May 18, 2021 action and its alleged "policy" barring any member of the Ten Residents Group and any member of the public involved in a controversy with the Town from speaking during public comment topic is an egregious abuse of the Board's discretion. It is a clear Open Meeting Law violation. The May 18, 2021 violation was intentional. The alleged "policy" is intentional as it was allegedly adopted by the Board. This is particularly egregious because the Board Chair, the former Chair attorney Teitelbaum and Town Counsel knew or should have known that such a blanket prohibition contravenes First Amendment rights. It is obvious retaliation against member of the Ten Residents Group and is intended to silence them and anyone else who may challenge any Town decision, permit, or position. Worse, neither the Board nor any Board member is a party to the DEP Appeal. The alleged "policy" does not protect the Town or the Board from any risk involving litigation with a resident since the "citizen comment" period is for citizens to comment: the Board is not required to respond to any comment about a controversy or litigation. The policy, written or as adopted by the Board on May 18, 2021 is an egregious abuse of the discretion afforded the Board chair regarding public comment.

What action do you want the public body to take in response to your complaint?
