## 5. CITIZENS COMMENTS

Present before the board: Eric Lintala

Mr. Lintala was before the board with a concern he is dealing with trying to get an issue solved with the Zoning Board of Appeals, he stated that they can't seem to have a quorum or when it comes time to vote on this property two of the members recuse themselves. Chairman Tropeano explained that at the meeting tonight they are going to appoint a member to hopefully deal with the quorum issue. Attorney Bowen was asked a question regarding voting and he explained that on a 5 member board a vote to deny requires only 3 people to vote and a vote to grant would require 4 members to vote.

Selectman Slavin stated that an application will be filed within the next 4-5 days for the traffic light at the end of Swifts Beach and Marion Road, this process could take up to 3 years to be installed.

Selectman Munise stated that some committees are ineffective and inactive and are failing to act on committee applications. He inquired as to the process and who was

the appointing authority and if send the application to the committees was a requirement or courtesy. He also suggested that if committees are unable or unwilling to act on a recommendation the Selectmen should review the application and act upon them. Selectman Tropeano, thought Selectman Munise was correct and was going to check on it.

- b. Conference call with Turning Technologies regarding electronic voting. Greg Alexander from Turning Technologies was on the phone providing the board with a presentation on electronic voting. He provided the board with a slide show on how the motions would appear on the screen at Town meeting and how the voting would appear as well. He also went over the cost of the hand held units and what it would cost for leasing and purchasing, they did agree that leasing would be the best option since its \$2000 for 400 units and with the change in technology it would always be up to date.

d. Update from Affordable Housing Trust Fund. Present before the board: Sandy Slavin, Clerk

Selectman Munise inquired as to why the committee has not been meeting and why they have failed to act on appointments for the committee. Ms. Slavin stated that the Affordable Housing Trust was reactivated in 2009. One of the goals was to increase the number of affordable units in Wareham; they would meet once a month but found

it difficult to make anything happen. She said that they did talk about dissolving the housing trust until Selectman Slavin stated that it would be in the best interest for the Town of Wareham to keep the trust but it didn't need to be active to allow for the Town to apply for grants.

e. Any other Town business not reasonably anticipated 48 hours prior to the posting of this meeting.

## 10. TOWN ADMINISTRATOR'S REPORT

Mr. Sullivan stated that they recently had a successful auction, one home in Onset sold for \$67,000 plus \$5000 in fees and a parcel of land sold for \$8600 also plus \$5000 in fees. Both of these properties were in tax title.

#### 11. <u>LIAISON REPORTS/INITIATIVE REPORTS</u>

Selectman Slavin stated that not much has been happening with SPREDD for the summer months. The Cannabis Control Commission in regards to social clubs has been put on hold.

Chairman Tropeano stated that they have been dealing with ongoing issues with Odor at the Sewer plant. He stated that they are working on an independent evaluation to stop the odors and hope they can come up with a solution that works. He also stated that last week someone came before the board saying that perhaps if the train whistle was louder than the person who was on the track wouldn't have been injured, he said that at one time he was in agreement with the owners of the properties nearby about lowering the whistle at the tracks until they found out that the law doesn't allow for that anymore and wanted to make it very clear that the whistles were blowing at the time of the accident.
