All summer the Center coordinated with the Onset Bay Center with monthly programs such as kayaking and clamming. This month is the last program on Charts and Knot Tying. Exercise programs such as Chair yoga, Tai Chi, Chair Volley Ball and a Weekly Walking Group have started up again. And for people who prefer more sedentary activities there's cribbage, mahjong, making mats for the homeless, and the weekly coffee and conversation sessions. Bingo should resume sometime soon. Craft classes have also started and in October, the monthly Garden Therapy class with the Wareham Garden Club will begin.
