RE: GATRA proposal to eliminate service to Shangri-La/White Island Shores

Mr. Sullivan and Ms. Whiteside:

I am writing to provide information regarding the potential impact of GATRA's proposed elimination of bus service to the Shangri-La/White Island Shores neighborhood in East Wareham.

Based on the most recent American Community Survey data available, nearly 73% of the households in the White Island Shores Census Designated Place are considered to be low- or moderate-income. A high percentage of low- and moderate-income households has been the trend historically as the neighborhood has evolved from a summer community to a year-round community.

The "Link 3" route runs from Shangri-La to Cranberry Plaza on weekdays from 11:10 a.m. to 2:30 p.m. According to GATRA's 2020 Comprehensive Regional Transit Plan, the route should be eliminated due to "very low ridership; less than three people daily," though respondents to a survey referenced in the plan indicated that they would benefit from those buses running more frequently.¹ The plan also indicates that the Shangri-La route is among the least expensive to run, costing \$3.28 per revenue mile.

While bus service to Shangri-La/White Island Shores may not be the most efficient to run, eliminating it would create a food and transportation desert for the neighborhood's most vulnerable residents.

Those without a vehicle would only reasonably be able to access the 7-Eleven convenience store on Barker Road, assuming they are able to make the trek, which is upwards of a mile from some areas of the neighborhood. Food, toiletries, and other necessities are typically priced more expensively at convenience stores compared to larger retailers such as Stop and Shop and Dollar Tree, both located on the bus route in Cranberry Plaza.

Considering the percentage of low- and moderate-income households, it is reasonable to surmise that many in the neighborhood receive SNAP benefits (commonly referred to as "food stamps"). Providing access to larger retailers for residents in need allows them to stretch their limited household budgets and benefits further. (Grocery delivery services are not a viable, long term option for these households.)

From a safety perspective, the neighborhood lacks proper sidewalks throughout. Pedestrian crossing at Plymouth Avenue in the area of Glen Charlie Road is dangerous. Despite posted speed limits, many vehicles drive too fast.
