Mr Pichette read the project for an upgrade to a title 5 nitrogen reducing septic system and recommends the approval with a Negative 3 due to the buffer zone.

Elissa Heard – Important to follow the bylaws

Michael Mercier - Questioned about the higher elevation and grading

Sand Slavin – Driveway length is concerns, Should be a buffer between the house and the no activity zone. Possibly some boulders.

JC Engineering response – noted with the bolders

Motion to continue the hearing 3-16-21-Motion and 2<sup>nd</sup> to continue. Approve: 6-0-0

Remove and replace a section of seawall 82 Pinehurst Drive

Mr Pichette read the project . 30ft Seawall is being removed. Mr Pichette noted there will be excavation needed and should be done on low tides. Also the Commission steps should note that the DMF states that all materials stay away from the salt marsh. DEP file number was not supplied so we would need a continue.

Mr Pichette read the project. The Solar Arrary is next to wetlands in three sections noted 36,44,48. There was clear cutting on the Nothernside area without permits. Riverfront that was degraded due to the scope of work. Restoration plan needed. DEP file number of the project should show how the redevelopment of the river front. Order of Conditions for restoration of the river front should be noted. Town By Law should not allow solar arrays next to Riverfront.

Linda Rinta noted the company scaled back from the original design

Elissa Heard – Stated the changes benefits the project but the cutting of the trees was an issue that was not permitted

Michael Mercier – asked how many miles from the other property

Sandy Slavin – Restoration along the 100ft wetland area is needed

Mr Pichette read the project located at 1032B Shell Lane for a small dock and Pier. Stated the project was revised to 197ft Pier. Stated the Ell grass study was none Division Of Mass Fishery stated there would be impacts to local shell fish/fish.

DEP file stated impacts to the Salt Marsh. David Pichette stated should not be approved due shellfish and impose on recreation resource areas

Attorney Mark Connolly stated the standards are met without impacts. Mark also stats the standards and changes are compliant.

Cape and Island Engineering – proposal 44ft gangway sections reduces in piles to 10 piles providing float stops helps with Salt Marsh and thus benefits shellfish in the area.

Brad Holmes –Would plant oyster seeds and Cohogs seed per Buzzards Bay Colalition

Denise Schulz---recreational activities would be restricted. Towns ByLaws stats to provide not a negative impact. Town Of Wareham bylaws states that swimming and or diving as such activities might be limited.

Sandy Slavin – Questioned the ramp float storage? Engineering stated the float would be stored into flat land

Dave Pichette—Fload Zone issue when bad weather, storage should be uploaded in a safe area Sand also mentions about the seeding and how they will grow and when the planting would be.
