## IV. PUBLIC HEARINGS

A. RDA – Morris Mendez, c/o JC Engineering, Inc.

Present before the Commission: Brad Bertollo, JC Engineering, Inc.

A site inspection was made at 107 Glen Charlie Road. The project involves upgrading a septic system in the buffer zone to Spectacle Pond. An existing cesspool is to be replaced by a new Title V nitrogen reducing system. The new leach field will be 95' from the edge of the pond and is being placed up near the road at the furthest location on the lot possible from the pond. Hay bales will be placed between the work and the resource areas on either side of the dwelling as shown. A liner will be placed around the system also. Minimal grading is proposed. Mr. Pichette recommended the issuance of a Negative Determination #3 for the project.

#### B. RDA – Melissa Lima

A site inspection was made at 25 Rose Point Ave. The project involves repairing and replacing a porch/mudroom in the buffer zone to a salt marsh, within the riverfront area of the Sippican River. An existing 10x20' covered porch is to be reconstructed in the same footprint 26' to the edge of the wetland. The project will involve the installation of three big foot sono tube footings. All work is to be done by hand. Erosion control will be installed between the work and the resource area. Mr. Pichette recommended the issuance of a Negative Determination #2.

C. NOI – Garry Buckminster/Wareham Harbormaster/Shellfish Dept., c/o The Nature Conservancy – SE76-2432

Present before the Commission: Steve Kirk, Nature Conservancy

Garry Buckminster, Harbormaster

The project site is off of the east side of Onset Island. The project is an oyster habitat restoration project proposed within land under the ocean, land containing shellfish, and within the estimated habitat of rare and endangered species. The purpose of the project is to establish a permanent oyster habitat by placing crushed shells to act as substrate for oyster spat to attach to. It is proposed to place 100 cubic yards of aged sea clam shell cultch in piles distributed over a one acre area. The area would be marked with buoys on the water. The resulting cultch piles would then be seeded and monitored over time and reseeded in the future. A barge would be used to transport the shell material from the shore to the project site. The shells would be transported in totes on the barge and then dumped at the site by hand. The shell piles would then be seeded with oyster seed. Comments have not been received from the MA NHESP, or the MA Division of Marine Fisheries (DMF). A DEP File # has been received. Mr. Pichette recommended a continuance at this time until comments from NHESP and MA DMF are received, but otherwise, he approves the project.

B. NOI – Kenneth & Susan Nelligan, c/o JC Engineering, Inc. – SE76- 2431

Present before the Commission: Brad Bertollo, JC Engineering, Inc.

Ken Nelligan, Applicant

The project involves the construction of a slab foundation under an existing elevated dwelling within the buffer zone to a wetland, within the riverfront area of Cedar Island Creek and within a Coastal Flood Zone. A new concrete slab will be poured under the existing 28'x52' dwelling within Coastal Flood Zone VE el 18. 4-8 inches of material shall be removed under the dwelling which is mostly crushed stone and then the new slab would be poured. Any extra material shall be removed from the site. It is then proposed to enclose the columns supporting the dwelling with breakaway panels to create a garage area under the dwelling

Mr. Leggett had asked at the previous hearing if the break-away panels on the columns could be secured to the columns.

The applicant has submitted a revised plan. The revised plan has removed the concrete slab and proposed a ground level deck with crushed stone as suggested at the previous hearing. It was also suggested at the previous hearing to remove the front steps and construct a concrete patio. The plan was revised to reflect this recommendation.

A DEP File # has been received. Mr. Pichette recommended the issuance of an Order of Conditions.

#### A. Dylan Arsenault – 1067 Main Street

A violation has occurred at 1067 Main Street. The violation involves the removal of vegetation along the edge of Tremont Pond adjacent to the location. The owner had removed vegetation along the edge of the pond for a distance of 30'.

Mr. Arsenault stated he was removing debris from the area. The area in question along the pond appears to be on Town property. There was also some additional removal of vegetation and landscaping activity in terms of grading and adding loam in the buffer zone to the pond. The owner was directed to install hay bales along the edge of the disturbance.

The owner is now trying to clear the old order. Mr. Pichette recommended the issuance of the Certificate of Compliance with the box checked off that the order has expired and the project never commenced.

MOTION: Ms. Lydon moved to grant a Certificate of compliance for Charles Oneil & further, the project has expired and never commenced. Ms. Slavin seconded.
