# **COA Director update**

- a. An offer has been extended to a full-time community outreach person.
  - Responsibilities include; Fuel assistance program, housing application assistance, medical transportation, food stamps, work with Old Colony Elder Service.
  - ii. Newsletter, in charge of programming (including set up and details of programming), work with COA on Partnerships (Cultural Council Reception, Land Trusts to offer Hikes), Housing Authority, Mobile Park liaison (to promote COA Services) and educate the public.
- b. COA received a donation of ice cream from Joe Salerno. Sharon Rice asks Sharon Boyer to please move the ice cream from 208 to the freezer.
- c. AED Update
  - i. Pads expired and replacement cost is roughly \$50
  - ii. Battery expires in June and the replacement cost is roughly \$386 with a 30-week back order.
  - iii. Annual service expected cost is \$485.
  - iv. The downstairs AED machine needs service.
- d. Safety Concern
  - i. A homeless man entered the senior center with a knife. Concerns for multiple people in and out of the senior center and concern for their safety.
  - ii. Sharon Rice reminds all that she needs to be the first call, so she can try to deescalate the situation.

- iii. Melissa Kauranen asked the policy on weapons. Does the town have a weapons policy that the COA can intermittently use until the COA has their own policy in place.
- iv. Once staff are in place, Sharon Rice will look for grants to help fund additional security measures.
