MINUTES OF MEETING OF WAREHAM FINANCE COMMITTEE

L CALL MEETING TO ORDER

The meeting was called to order at 6:30 P.M.

III. FINANCE COMMITTEE MATTERS

A. Approval of meeting minutes: March 13, 2024 & March 27, 2024

There were no corrections to the March 13, 2024 meeting minutes, thus they were approved. The March 27, 2024 meeting minutes were not handled at this time.

- B. Presentation/discussion re: Community Preservation Committee Town Meeting Warrant articles – David Heard, CPC Chair
 - i. ATM Article 11 Tremont Nail Remediation Project
 - ii. STM Article 10 Tremont Nail Remediation Project
 - iii. ATM Article 12 FY25 Community Preservation Fund Reserves
 - iv. STM Article 13 Return Unused Funds from Completed Projects

Mr. Heard explained that actions on the STM Articles 10 & 13 need to acted upon before the end of FY24.

Mr. Heard read STM Article 10 into the record. He explained that \$76,000 is being requested for principle & interest & \$19,937.62 in short-term interest for the bond. He provided information on the background of the Tremont Nail Remediation Project which involved clean-up of contamination of the property that the Town purchased in 2003.

Mr. Heard read ATM Article 11 into the record. The funding request will complete the payments.

Mr. Heard read ATM Article 12 into the record. He noted the following allocations of monies:

- \$60,000 for administrative costs
- \$120,000 for open space reserves
- \$120,000 for historic preservation reserves
- \$120,000 for affordable housing reserves

Mr. Heard noted the State matching funds will be less than last year. The fund balance at the end of FY23 was approx.\$3 million. Ms. Scogin briefly noted the process for requesting funding & this year have not had any requests.

Mr. Heard read STM Article 13 into the record. He discussed unused funds being returned from various projects.

C. Report on request to pass over ATM Article 14 - Recycling Center

Ms. Scogin stated this article was a Citizens Petition article. It is being passed over because there are funds available that the petitioner(s) were not aware of. The petitioner(s) have requested this article be passed over.

D. Presentation/discussion re: Bylaw Review Committee Town Meeting Warrant articles – Sherry Quirk, Bylaw Review Committee Chair

Ms. Quirk noted that Nora Bicki is also a member of the committee. She discussed the process that was following in reviewing the Bylaws & consulted w/ Ms. Moran & Ms. Scogin during the review. She summarized that the Bylaws were "a mess" & noted some of the issues w/ the Bylaws. She spoke re: the process in considering deletions in the Bylaws.

i. STM Article 14 - Delete Several General Bylaws

Ms. Quirk discussed the following changes/deletions w/in the Bylaws:

- Street rules
- House numbering
- Town Administrator's enforcement authority

Ms. Quirk stated if the Town Administrator's enforcement authority is deleted, the enforcement would fall to the applicable department(s).

Ms. Quirk stated these proposals are just some of the changes/deletions that are being proposed currently. There will be more going forward.

ii. STM Article 8 - Duty of Town Clerk

Ms. Quirk explained what a non-substantive change is. She noted the Town Clerk is bonded & noted the Town Clerk's authority re: Attorney General & Town Meeting review. If the Town Clerk makes an editorial change, it becomes part of the public records. Brief discussion ensued.

E. Presentation/discussion re: STM Article 17 – Amendment to Wareham Protective Bylaw – Joshua Faherty, Conservation Administrator

Ms. Scogin noted Mr. Faherty has a Conservation Commission hearing tonight & is unable to be present. An explanation of the article was submitted to FinCom members. She asked if the FinCom members would still like to meet w/ Mr. Flaherty given the information that was submitted for the article.

Ms. Scogin stated as she understands the article, it would allow more flexibility in the Wetland Protective Bylaws due to constant State regulation changes re: conservation.

Brief discussion ensued re: the article & the FinCom members concurred that they do not need to meet w/ Mr. Flaherty.

Ms. Scogin noted the voting grid for FinCom & the Selectboard.
