E. Report on Comprehensive Wastewater Management Plan Advisory Group meeting on May 31, 2023

Ms. Scogin attended said meeting presented by the Town's sewer engineers to create a 20-year plan. She noted attendees. The plan will consist of a needs assessment, alternatives & recommendations for what would be most cost effective. The study will be completed in one year. The meetings will be held every two months.

F. Report on discussion w/ Town Administrator re: quarterly reports

Ms. Scogin met w/ the Town Administrator & will meet w/ him once per week. She has submitted the April financials to the FinCom & the Town Administrator will submit & speak to the FinCom about the year-end report in the next 60-90 days.

G. Discussion of liaison assignments & duties

Mr. Cammarano discussed how the assignment process was conducted in the past. Some departments/committees are more pressing than others. Mr. Stefanski stated there used to be an item on the agenda titles "Liaison Reports" where FinCom members can report any information. Ms. Scogin stated the liaison assignments should be made after the reorganization of the FinCom & a list of what is expected from liaisons should be generated.

Mr. Smith feels there should be public input before the FinCom on articles. There should be a public comment period on articles when presented to the FinCom. Brief discussion ensued.
