IV. FINANCE COMMITTEE MATTERS

A. Review 2018 Annual & Special Town Meeting articles:

1. Special TM: Cemetery Rules & Regulations

Present before the FinCom: Kathy Bird, Cemetery Commissioner

Jack Silva, Cemetery Commissioner

Ms. Bird stated at the last Town Meeting, there were some concerns re: language included in the rules & regulations. The Commission went back & removed verbiage concerning the Town Administrator that seemed contentious.

Ms. Bird explained the current rules & regulations are 40 years old. She stated the old rules & regulations do not address leaving family lots to heirs, for example. The proposed new rules & regulations need to be passed to be in compliance w/ MA State laws.

Ms. Bird noted by removing the verbiage re: the Town Administrator, the verbiage does designate (by Bylaw) power to the BOS. She also noted these new rules & regulations have no financial impact to the Town.

Brief discussion ensued re: perpetual care & powers of the BOS.

3. Article 7 – FY19 School Dept. Budget

Present before the FinCom: Kimberly Shaver-Hood, Superintendent

Michael McMillan, Financial Director

Ms. Shaver-Hood stated they are working from the first budget they proposed from the School Committee & they are making changes to that budget.

Ms. Shaver-Hood & Mr. McMillan proceeded to make a presentation on the school budget & proposed changes. (Attached as reference). Mr. McMillan noted the School Committee will be voting on the proposed revised budget next week.

After the presentation, discussion ensued re: if there is a contingency plan if a new school does not come to fruition.

Discussion ensued re: a proposed plan to charge fees to ride buses for grades 7-12.

Lengthy discussion ensued re: some Finance Committee members believing that the plan presented is not sustainable.

Discussion ensued re: a Prop. 2 ½ Override & school choice.

Mr. Heard feels the Town will have to absorb some incremental costs w/ the proposed plan of closing a school, such as moving costs, portables, etc.
