#### A. Town Meeting Articles:

Mr. Buckland puts together slides for the following Zoning Articles to present to the Planning Board.

• Under Article 10, Amend Section 1042: Reduce minimum landscape buffer between commercial and industrial properties

The table sets forth the minimum required additional landscape buffer in feet between a proposed use and an existing adjacent use. The Board expresses their ideas and concerns, and Mr. Swenson summarizes them. On the Board's behalf he states there are errors in the chart that need to be corrected. Office category is a subset to Commercial, and in order for the chart to line

• Under Article 3, Amend Section 390: to permit a Medical Marijuana Dispensary in the same zoning districts allowing retail sales in Marijuana Establishments

Mr. Buckland states that currently the Medical Marijuana Dispensary is only allowed in the Institutional Zoning District. What is suggested it that it be allowed by Special Permit in other districts where other marijuana establishments are allowed.

Present before the Board: Selectman Peter Teitelbaum, Esq.

Mr. Teitelbaum stated that amending the By-Law to accommodate a single vendor is not recommended at this time.

MOTION: Mr. Swenson moves to recommend tabling this for further study. Seconded.

• Under Article 3, Amend Section 390: to establish a moratorium on Social Consumption type of marijuana establishments

Mr. Buckland suggests a one year moratorium be created for Social Consumption.

MOTION: Mr. Daskalakis moves to recommend and approve it. Mr. King seconds.

• Under Article 6, Amend Section 622: To make the dimensions for Wareham Village 1 [WV1] and Wareham Village 2 [WV2], the same as the Onset Village 1 [OV1] and Onset Village 2 [OV2]

Mr. Buckland states the proposed by-law amendment would make the density the same within the districts but recommends waiting until the Urban Designers do a study of the downtown area.

MOTION: Mr. Baptiste moves to table any change to this Article. Mr. Daskalakis seconds.

• Under Article 11 Signs, Amending sections to create "content neutral" sign regulations in accordance with State Attorney General's recommendation

The Board suggests setting up a further study committee.
