    - ii Discussion and agreement that it is not in the WRA's best interest to spend work cycles on town property that it doesn't have authority over until the party that does, typically the BoS, has engaged and agreed with the WRA on a plan of action.
  - b. 4 Recovery Road
    - i No update
  - c. Bay Pointe Country Club
    - i BayPointe expects to have Phase 2/3 modifications in front of the Planning Board in June, which will include public hearings.
    - ii No update on Phase 4 (townhouse/condo project on CEDA land). Target is July for initial planning.

    - iii Aspen Blue is preparing building update plans
    - iv Remediation testing results expected in 2 to 3 weeks
      - River barrier looking more likely

    - v Nemasket Kayak has shown interest in moving to TNF
      - ♦ Would require an RFP
