Renewals will continue to be processed through the Town portal.
- e. During this discussion Ms. Whiteside explained that there will be several dangerous dog hearings coming up including the one which will be held on June 13<sup>th</sup>. She urges residents who own dogs to not only register them with the Town but to also make sure they are leashed at all times. If you have any problem involving a dog, make sure to report it to the Department of Natural Resources as soon as possible so it will be on file. One more reminder from the Board- the dog park is open from dawn to dusk but there are absolutely no dogs allowed on any of the Town Beaches at any time.
