5. ANNOUNCEMENTS

Mr. Slavin announced the coming of the Jewish New Year and Yom Kippur. He explained how the holiday is celebrated and wished everyone who celebrates a Happy New Year.

Mr. Chadwick made the announcement that Fall School sports have begun. Buses are back on the road again around 5:00 p.m and it is important to stop for the red flashing lights. Fines are hefty.

Ms. Whiteside announced the Veteran's Parade will take place on November 11th at 10:00 a.m. It will begin at Besse Park and will end at Centre Park. Participants will include stilt walkers and balloon makers and more participants are welcome.

7. 7:15 HEARING — J.P. Noonan

MOTION: Mr. Chadwick moved to open the hearing on the Application from J.P. Noonan 2381 Cranberry Highway, West Wareham for a Flammable Fluid License for the keeping, storage and sale of diesel fuel and motor oil in accordance with the provisions of Chapter 148 of MGL., Seconded. **VOTE:4-0-0** The hearing was declared open.

Mr. William Madden was present before the Board on behalf of the applicant. Board members had questions. Mr. Nazih Elkalassi was present to speak to the application, and stated that he believed the applicant need to apply for a Variance from the ZBA. Because there were several questions left unanswered the Chair suggested a continuation to the hearing.

- **c. MOTION**: Mr. Chadwick moved to approve the opt-out and reduction fees applications for Curbside Billing FY24 in the amount of \$1,003.76, Seconded. **VOTE**: **4-0-0**.
- d. Discussion regarding Center (Centre) Park regulation. (February 1987). No vote necessary.
- e. **MOTION:** Mr. Chadwick moved to adopt a Code of Conduct, as suggested by MIAA., seconded. **VOTE: 4-0-0**
- f. **MOTION:** Mr. Chadwick moved to to accept a \$100.00 donation from Mr. William RC White to the Council on Aging, seconded. **VOTE: 4-0-0.**
- g. Discussion and possible vote on enforcement options regarding Mr. and Mrs. Russell Kriehn's Dangerous Dog Hearing. There will be a hearing held on October 3, 2023 with the Kreihns. (**NOTE:** Mr. Chadwick recused himself from discussion on this item.)

10. TOWN ADMINISTRATOR'S REPORT

Mr. Sullivan mentioned weather reports about Hurricane Lee including flood damages. The town is keeping an eye on it.

11. LIAISON/INITIATIVE REPORTS/BOARD'S COMMENTS

Mr. Slavin watched a 4 hour Chapter 70 tutorial about school functions including revenue and expenses. He stated that there is no question why it is difficult to understand. The state program has many flaws for towns, some equitable, some inequitable. He noted that Wareham complies with the foundation request and that we aren't underfunding the Wareham schools at all.

Mr. Slavin had a phone conversation with Tom Cahir from Bourne, Executive Director of the Cape Cod Rail Transit Authority of Hyannis. In the past, he lobbied for the Cape Cod Flyer and is presently lobbying for the Commuter Rail to come to Buzzards Bay. He also lobbied for the train to go to Hyannis, but with the existing condition of the train rail and limitations of 20-30 mph. There are also of residents that don't want the train going by in back of their houses. The Healey Administration is pushing the project. Mr. Slavin will keep everyone updated.

Mr. Slavin discussed the MSBA program. He explained that it pays for schools 40%-70% as a rule. There is a bill that mirrors the MSBA infrastructure, which could give Wareham a new police station. That bill has started to move again and we are going to watch to make sure we are actively involved because a new police station in Wareham is beyond our means.

Ms. Wurts mentioned that the Planning Board is heavily involved with getting the Articles ready for this year's town meeting.

Mr. Slavin also mentioned the Cannibis Control Commission. It is strongly pushing cannabis cafes and making rules and regulations to get this going. He would like to put this subject back on the Select Board agenda soon.

Mr. Chadwick mentioned that the Vikings lost their recent game, but that Tyrell Pires has been nominated for Southcoast Player of the Week. He had 11 tackles on defense, carried 15 times for 50 yards and a touchdown. He is only a freshman but he has a promising future in

the NFL. Mr. Chadwick wanted people to go to Southcoast Today (online) to vote for him for Wareham's own Player of the Week.

Ms. Whiteside reminded everyone about the Veteran's Day Parade looking for more participants, including youth groups, and 501C3's. It is already an exciting lineup, but more participants are encouraged and welcome.
