Ms. Susan Noonan asked where the letter to the Governor, previously authorized, regarding the Immigrants/homeless was.

ANNOUNCEMENTS 5.

Mr. Slavin stated the deadline for CPC applications is the second week of January. There is a scheduled CPC meeting to be held tomorrow.

Mr. Slavin reported that he had been in touch with Mass DOT regarding the recent accident on the intersection of Swift's Beach Road, and Rte. 6. Rte. 6 is a State Road, and the original plan was to have a traffic light installed in 2024. Now the State is saying it needs a new traffic study, and the process will probably postpone the installation of any traffic signal until 2025.

Mr. Slavin reported he was disappointed that the School is contemplating a budget request of more than 10% increase over this year's amount, information he learned at the joint December 7th meeting. This is a figure that is simply unattainable, because it leaves no room for any other department in the Town for any increases.

The MBTA has no new updates on projects.

Mr. Slavin reported that he is working with GATRA and SRPEDD to create evening bus service throughout Onset Village, which would greatly enhance business opportunities for the Village.

Mr. Chadwick expressed his concern that the School Department is not addressing their budget with a view to the overall Town budget.

Ms. Whiteside reminded residents that the 21^{st} of December is the shortest day of the year, and that there will be a ceremony recognizing the homeless at Turning Point that evening.

Ms. Whiteside stated the Commonwealth has notified the Town that the homeless/immigrants currently housed in the Atlantic motel on Depot Street will be moved to another location outside of Wareham on December 20th, and that that motel will no longer be used by the Commonwealth.

The Board members discussed the fact that the law requires the hours of operation for any alcohol license holder to be stated clearly on the license. Wareham has always followed this practice. Therefore it is incumbent upon license holders to ask the board to adjust hours, if they choose to follow 'seasonal hours adjustments.' 9. TOWN ADMINISTRATOR'S REPORT

Mr. Sullivan asked for a moment of silence for Chris Park, a long-time police officer for the Town.

Sullivan reiterated the information given by Ms. Whiteside about the Atlantic motel population. He thanked everyone in Town who has donated food, clothing and other necessities, to try and make the individuals comfortable and welcome.

Sullivan stated the Library recently received the good news that it has been recertified by the Commonwealth.

Sullivan addressed the recent renovations of the library, made necessary by the flooding several months ago. While some of the cost was covered by insurance, much additional work was performed by staff at Municipal Maintenance, including moving all shelving. He praised the work of MM.

The library roof was recently repaired.

The bad news concerning the library building is that the Town asked for bids to 'fix' the existing HVAC system, as well as to replace the HVAC system. The 'fix' bid came in at approximately 1.7 million. The 'replacement bid' came in at 3.2 million. Both of these figures are substantially above the expected. Mr. Sullivan expressed that the building was originally built and designed approximately 25 years ago and, unfortunately, was now showing age and wear.

Mr. Sullivan explained that the Town has 'maxed out' its debt service budget, with the payments for the elementary school, as well as the roof repairs for the middle school. The middle school roof is expected to cost the town 6.7 million, net of MSBNA repayment. The Town does not have the capacity to borrow any further funds under don-excluded debt funds.

Mr. Sullivan showed a couple of pictures of the renovation work recently completed by Municipal Maintenance, which was a cleaning up the room, and a complete refinishing of the floor. Previously completed was the replacement/repair of the slate roof, followed

by the replacement/repair of the rubber roof. This improvements allowed refurbishing work to be accomplished, including fixing the ceiling and refinishing it.

Plans for the future include replacing the curtains in windows as well as on the stage, repairing and repainting the walls, installing a baffling system to reduce the echo, and replacing the child sized seats in auditorium loft with adult sized seating.

Mr. Sullivan praised the Police Association for its continued efforts, specifically the stuff a cruiser even, and shop with a cop.

Sullivan praised the Town employees who donated gifts as well.

Mr. Sullivan thanked Mr. Foster, Ms. Lauzon, Ms. Nichols and the Assessors office for getting the Tax rate set and certified.

Mr. Sullivan praised the NR and other for their efforts to secure the remembrance trees in Besse Park.

10. LIAISON/INITIATIVE REPORTS/BOARD'S COMMENTS

Mr. Slavin reported that the MBTA is beginning to address a capital improvement program.

Mr. Slavin discussed the Cannabis Commissions lack of decisions, as well as possible loss of control over impact fees from cannabis locations. He reminded the town that we had voted a one-year moratorium to allow the planning board and other time to set parameters for locations of cannabis cafes.

Mr. Slavin stated that there is at least one more year of the improvements to Routes 6 and 28 which is a state project.

Mr. Slavin announced that GATRA has plans to develop a garage/depot in Wareham, in the western part of Town.

Mr. Slavin reiterated his dismay over the presumed 10% budget increaser from the schools.
